Royal Commission Case Notice + Crown Court Enforcement Stay Filing Notice

6<sup>th</sup> January 2019

1. The Parliament Session Opening Queen's Speech on 19 December 2019 announced a Royal Commission for Corruption Remedies.
2. A series of Top Level Corruption Investigations discovered Top Politicians, Top Judges and Top State Officers sell Market Frauds to Organised Criminals and provide Protection Frauds for the Corrupt Officers who manage them. Corrupt Officers sold Protection Frauds to Drug Dealers and used Prosecution Frauds to get a Forced Sale of Viable Businesses for Money Laundering.
3. The Royal Commission Cases are Protection Tests that will discover whether Law Courts continue to provide Protection Frauds for Corrupt Officers or Protection Justice for Citizens.
4. Citizen Mr Yediayli helped to get the Royal Commission. He is helping to service it. He is a Turkish Citizen with British Residency Rights + Turkish Literacy + English Illiteracy + Business Administration Skills Deficit + Fast Food Shop Skills + Viable Business called Barry's Fish Bar at 222 Devons Road, Bow E3 3PN. Corrupt Officers planned a Forced Sale + Business Theft.
5. The Business Claim QB 2019 003741 is for the Purchase Price or Business Repossession. It is Damage Mitigation Action that should have got a £150,000 Damage Reduction of the Corruption Claim QB 2019 003984 against the Attorney General, Metropolitan Police, Ministry of Justice and Law Society.
6. The Damage Mitigation Applications in both cases gave the High Court Masters the choice of Damage Reduction for the State or Business Price Waivers + Unjust Enrichment Frauds for the Buyers. They chose the Price Waivers + Unjust Enrichment Frauds. They called on the Metropolitan Police for Business Theft Investigation Frauds against Citizen Mr Yediayli.
7. On Business Theft Complaint Day 60 the Metropolitan Police held the Complainant Interview and received a Case Explanation + Chronology + Criminal Conspiracy Evidence Notices but not the Actual Evidence. It got Case References up the Common Chain and No Disclosed Action. The failure to make Actual Evidence Requests resulted in a Case Details Request on Complaint Day 90 at Bow Criminal Courts Administration Office. It got the Case Reference 1900809731 + Hearing Dates. They were used to complete the Convictions + Sentence Appeals and file them in the Criminal Appeals Office that day. The Criminal Appeals Officer provided Stamp Receipt Proof on Multiple Originals of the Appeal Papers and the Enforcement Stay Application to the High Court
