The Royal Commission

The Citizen, Crown and Lord Bishops have Justice Responsibilities known as the Equity Monarchy Trusts. They have Corruption Control Jurisdictions that govern Parliament Session Powers. The Ultimate Sanction is a parliament Session refusal and Forced General Election with Mass Publicity for the Corruption Proof, Remedy Denial Fraud Proof and Election Fraud Proof. It needs a Credible Choice for Voters. The Citizen, Crown and Lord Bishops managed a Corruption Remedy Process. It got a Forced Resignation from Prime Minister Mrs May and a Forced General Election. Integrity Tests before and during the Election Campaign Period got Election Fraud Proof against All Party Leaders. It invalidated a Repeat Forced General Election. The Crown and Lord Bishops imposed Corruption Remedy Conditions in the Parliament Session Agreement. They included a Royal Commission for Corruption Remedies. MP Mr Boris Johnson had made Protection Fraud Deals with the Protection Fraud Network to get Leadership Support and the Premiership. The Protection Fraud Network made Protection Proof Demands. The Prime Minister used Prosecution Frauds and Election Frauds as Protection Fraud Proof. Top Media Managers accepted it. They aided and abetted Election Frauds with Propaganda Services. The 2019 General Election got a Governing Majority of 80 MPs for Prime Minister Mr Johnson. The Election Frauds and the Royal Commission make it a Vulnerable Majority. Remedy Sabotage Frauds by Prime Minister Mr Johnson were Totally Predictable. Previous Parliament Session Agreements created Special Protection Rights that enabled Equity Lawyer Mr Ellis to provide Investigation Services for the Remedy Process. The Special Protection Rights continue. They enable the Equity Lawyer to manage Integrity Tests for the Royal Commission.
