John,

The Crown and Lord Bishops imposed Corruption Remedy Conditions in the Parliament Session Agreement. They required a Royal Commission to deal with Top Level Corruption.

Prime Minister Mr Johnson and Attorney General Mr Cox planned Remedy Sabotage Frauds against the Royal Commission. Citizens are using their cases for Integrity Tests of the Royal Commission

Please allow use of the Framing Frauds 2019 0860 + 0861 against you for Integrity Tests.

Please read the Framing Fraud Remedy Applications and sign all both prints.

Please inform All Prison Officers about the Prison Fraud Allegations and the Prison Records Evidence Production Application. Please ask Prison Officers for Personal Service Access to the Prison Governor.

Please ask the Prison Governor to scan the Signed Application for Email Service by the Prison Governor on the Crown Prosecutor and Crown Court and copy it to edward.w.ellis@gmail.com for the Royal Commission

Organised Criminals want Immunity Deals in exchange for Remedy Co-operation and Full Disclosure. The Deal Terms include management of their Organised Crime Organisations out of Criminal Business into Lawful Business. They need Safe Conditions. Some of the Royal Commission Integrity Tests are Safe Conditions Tests.

One of the Remedy Proposals is for a Secret Ballot of Prisoners + Prison Officers to discover who they say is Innocent or a Prison Fraud Victim. Some of the Prisoners will want Immediate Release. Others will need a Release Plan. It will get a Mass Release. We can then take a closer look at everyone else.

The Hard Criminals will get a chance of Immunity Deals. In some cases their Organised Crime Connections might already have included them in Immunity Deal Plans. They will say nothing until they get Safe Conditions Proof. The Hardened Criminals need to avoid doing anything that spoils Immunity Chances.

They need know Top Police and Top Judges provided Protection Frauds and Money Laundering Services for Organised Criminals. They used Prosecution Frauds to get Forced Sale Conditions and used Forced Sales for Business Thefts. The enclosed Criminal Summons Application dated 14th January 2019 explains it.

Please ask All Prisoners to keep their Case Papers in case they are needed as Similar Fact Corruption Proof.
