 - 2.1. On 29th September 1959 Robert Walker and Janette McLaughlin Donald married. On 14th January 1960 Janette Walker gave birth to a Twin Boy and a Twin Girl. On 12th February 1960 the Twin Births were registered in the district of Bellshill in the county of Lanark in Scotland.
 - 2.2. The Mother committed Child Desertion and got 2 Criminal Convictions
 - 2.3. The Mother assumed the Identity of Elizabeth Margaret Bennett and married the Lawyer Journalist and Politician Mr John Smith
 - 2.4. The Mother committed Identity Frauds against the Girl Twin using Perjury and Forgery to get True Birth Record Denial Frauds + False Birth Record Creation Frauds + False Birth Record Use Frauds
 - 2.5. The Mother became Baroness Smith
 - 2.6. The Girl Twin got Parent Fraud Proof and conducted True Identity Investigations.
 - 2.7. The Mother committed Investigation Sabotage Frauds against the Twin Girl using Family Sabotage Frauds and Children Thefts against the Twin Girl and a £2,000,000 Silence Bribe Offer
3. DNA Investigation Orders for All Citizens against the State and Baroness Smith and Scottish BBC Journalist Ms Sarah Smith to discover whether they are respectively the Mother and Half Sister of Elizabeth Docherty
