In 1989 Citizen Mr George Carter attended a football match and witnessed the Hillsborough Tragedy. He had contact with some of the Victims' Relatives. He received Corruption Reports from the Victims' Relatives against the Authorities. He had Protest Skills but lacked Corruption Remedy Management Skills. He believes Legitimate Protests made him a Corruption Target.

A series of Top Level Corruption Investigations got a Forced Resignation from Prime Minister Mrs May and the 2019 Forced General Election. Integrity Tests before and during the Election Campaign Period got Corruption Proof, Remedy Denial Fraud Proof and Election Fraud Proof against Organised Criminals, the Media, State, Law Courts and All Party Leaders. The Ultimate Corruption Remedy is a Parliament Session Refusal and Forced General Election with Mass Publicity for Corruption Proof, Remedy Denial Fraud Proof and Election Fraud Proof. It needs a Credible Choice. The Election Fraud Proof against All Party Leaders was Incredible Choice Proof that invalidated a Repeat Forced General Election. The Crown and Lord Bishops imposed Corruption Remedy Conditions in the Parliament Session Agreement. They required a Royal Commission for Corruption Remedies. The required continuation of Special Protection Rights for Equity Lawyer Mr Ellis against the Cabinet and Prime Minister that enable him to manage Integrity Tests for the Royal Commission.

Citizen Mr Carter has agreed use of his cases for the Integrity Tests

  - 1.3. He made a Racial Complaints that got Investigation Denial Frauds for a White Woman against him. She made a Racial Complaint that got Investigation Frauds for her against him. They destroyed the Video Record that was Guilt Proof against her and Innocence Proof for him.
  - 1.4. The Cheshire Authorities had a Black Man with Jury Trial Rights and a Bias Fraud Defence. They used Trial Fraud Blackmail to get a False Guilty Plea and deny Race Fraud Remedies.

1.5. Citizen Mr Mustafa allowed use of his case for a Corruption Investigation. It got Criminal Conspiracy Proof against the Witnesses, Investigators, Prosecutors, Defenders and Trial Judges. It includes Crown Court Audio Records that are Trial Fraud Blackmail Proof for the Citizen, Crown and Lord Bishops against the Defenders, Prosecutors and Trial Judges.

1.6. In May 2019 Citizen Mr Mustafa stood as an Independent Candidate for Crewe Central Ward in the Cheshire East Elections. He had Corruption Remedy Policies and got 55 Votes.

1.7. Labour Supporters thought he would stand as an Independent Candidate in the General Election. They used a Facebook Account with 20,000 Local Users for Paedophile Defamation Frauds against him. The Labour MP is reported to have made a Criminal Complaint. Cheshire Police ignored the Car Ownership Proof for him of a Hire Purchase Agreement, Motor Insurance and Vehicle Licence. They used Ownership Denial Frauds + Misrepresentation Frauds for a Car Theft Arrest Fraud + Custody Fraud + Mental Health Case Reference Fraud by Cheshire Police and Custody Fraud + Forced Medication Fraud by the National Health Service, with Corruption Protection Frauds by Attorney General Mr Cox and Prime Minister Mr Johnson

2. Council Tax Fraud Enforcement Prohibition Witness Protection Order + Restraint Breach Contempt Prosecution Prohibition Order + Contempt and Terrorism Penalty Warning for Citizen Witness Ms Neelu Berry against Redbridge Council, the Solicitor General, Attorney General, Secretary of State for Justice and Prime Minister for the Stated Reason that:
