Grounds: Fraudulent Breaches of Natural Justice + Human Rights + Overriding Justice Objective

Circumstances

The Citizen, Crown and Lord Bishops have Justice Responsibilities known as the Equity Monarchy Trusts. They have Corruption Control Jurisdictions that govern Parliament Session Powers. In 2017 Corruption Investigations got Criminal Conspiracy Proof against Top State Officers and Law Court Judges. The Crown and Lord Bishops used it to decide the Corruption remedy Conditions for the 2017 Parliament Session Agreement. They needed a Long Session of 2 ½ years to compete Corruption Investigations in the Law Courts, get Unfitness Cases against Top Judges and use them for Protection Fraud Investigations in Parliament. It got Criminal Conspiracy Proof against many MPs. Attorney General Mr Cox, Prime Minister Mrs May and Opposition Leader Mr Corbyn. It got the Forced Resignation from Prime Minister Mrs May, a Forced General Election. It got Corruption Remedy Conditions that required a Royal Commission for Mass Remedies and an announcement of it by the Queen in the Parliament Session Opening Speech on 19th December 2019. The Royal Commission needed Integrity Tests conducted before and after the Cabinet Reshuffle. The Business Management is Organised Crime Proof against the Landlord. The Tenant Mr Hastunc agreed use of the Business Lease Case for the Integrity Tests. The Possession Hearing got Criminal Conspiracy Proof against the Landlord and Hearing Judge. The Business Lease Case in the Law Courts and a Crime Complaint to the Metropolitan Police will enable the Royal Commission to observe Case Management by the Landlord, Tenant, Police and Law Courts. It needs another Settlement Opportunity for the Landlord before filing the Crime Complaint
