Stated Reasons

The Parliament Session Agreement between the Crown and Prime Minister Mr Johnson contained Corruption Remedy Conditions. They required that a Royal Commission get Corruption Remedies before the

Session End. On 19<sup>th</sup> December 2019 the Queen used the Session Opening Speech to announce the Royal Commission. Honourable Parliamentarians needed Criminal Conspiracy Proof to silence Corrupt Parliamentarians until Unfitness Cases got Corruption Findings + Terrorism Findings + Corruption Penalties of Dismissals and Crown Protection Forfeiture and Parliament Protection Forfeiture + Terrorism Penalties against Top Judges.

Citizens got Criminal Conspiracy Proof. Corrupt Officers tried to defend themselves with Evidence Frauds that included Forgery + Perjury + Evidence Destruction. Computer Records were not consistent with Judge Identities given on Court Rooms. Some of the Honourable Officers did what they could to reveal Secret Decisions and Order Forgeries and Computer Record Frauds. Others needed Crown Protection with Effective Enforcement by the Cabinet and Prime Minister to give them confidence for Remedy Co-operation. They needed Audio Records as Person Responsibility Proof against Identifiable Individuals.

Mr Sham Sood was an Illiterate Immigrant who spoke no English when in 1976 he came to England for an Arranged Marriage. He learnt basic English, had a successful working life, a successful marriage and 4 children. Medical Negligence caused the death of his wife. He used Medical Negligence Damages as Equity Capital that enabled the Two Older Sons to raise Buy to Let Mortgages and buy property on trust for him. He occupied one house and used the rent from flats to support the family. The 2<sup>nd</sup> Son, Mr Vishal Sood, made a Trust Declaration for the Father. Later he bought Land Frauds from Law Court Judges, got issue of Trust Claim Fraud B01B0873 with intent to defraud his Father. The Trustee Son and Law Court Judges used Trial Fraud Blackmail to get Agreed Orders. They included Sale Orders. The Trustee Son and the Mortgage Lender committed Sale Order Breach Contempt Frauds to prevent the Mortgage Repayment and got Contempt Immunity Frauds from the Law Court Judges. The Mortgage Lender then used the Sale Order Breach Fraud + Mortgage Repayment Sabotage Fraud for Mortgage Possession Claim Fraud F01PP7696. It was Criminal Conspiracy Proof against the Trustee Son, Lenders, Lawyers and Judges

Citizen Mr Sham Sood gave a Privilege Waiver and Confidentiality Waiver that enabled use of his cases for Remedy Management by the Honourable Parliamentarians, Lord Bishops and Crown. He used Criminal Conspiracy Proof for a Corruption Claim 2020 000968 against the Prime Minister, Son Trustee Mrs Sood, Beneficiary Lawyers Harris Waters, Bank of Scotland, Ministry of Justice and Law Society. It Interim Remedy Denial Fraud Proof against the High Court. It was used for the Fraud Appeal 2020 0742 to the Court of Appeal. The Stay Application dated 25<sup>th</sup> March 2020 in the County Court got Conflict Qualification Fraud Proof + Case Allocation Fraud Proof + Protection Breach Contempt Fraud Proof against County Court Top Judge Mr Dight and Conflict Qualification and Hearing Judge Recorder Mr or Ms Robertson. The Citizen has Limited Language and Management Incapacity for Court Frauds. Draft Order explained his case. The Telephone Hearing on 23<sup>rd</sup> October 2020 got a Participation Refusal by the Citizen and an Audio Record of Hearing Frauds by his Son and the Judge. Appeal Process Refusal Frauds forced the Set Aside Application.
