The circumstances

The Citizen Crown and Lord Bishops have Corruption Control Jurisdictions that govern Parliament Session Powers. They use the Corruption Remedy Proof Standard. It is Official Records that are Justice Proof for Honourable Officers or Guilt Proof against Corrupt Officers and Credibility Irrelevance Proof for the Victim. An Equity Lawyer is anyone with the expertise and commitment to get Proof Sets that meet the Corruption Remedy Proof Standard and knowledge how to use it to service the Equity Monarchy Trusts. Equity Lawyer Mr Ellis provides Investigation Services. He recruited Citizens, manages cases and gets Proof Sets that meet

the Corruption Remedy Proof Standard. The Crown and Lord Bishops use it to decide Corruption Remedy  
Conditions in Parliament Session Agreements. In December 2019 the Parliament Session Agreement  
between the Crown and Prime Minister required Corruption Remedies before the Session End. Honourable  
Parliamentarians needed Criminal Conspiracy Proof to silence Corrupt Parliamentarians until Unfitness  
Cases got Corruption Findings and Dismissal Decisions against Top Judges.

Citizen used their cases to get Criminal Conspiracy Proof. Corrupt Officers tried to defend themselves by use  
of Order Forgeries and Computer Record Perjuries. It created the needed for Hearing Audio Records as  
Personal Responsibility Proof against Identifiable Individuals

The Contempt Claim Fraud 2020 000286 got Fraud Proof that was used for Fraud Appeals 2020 0396 and PI  
10942. Fraud Appeal 2020 0396 got a Case Reference that got either Decision Denial Frauds or Decision  
Disclosure Denial Frauds by Appeal Lord Justices and a Bundle Filing Failure Case Dismissal Forgery by  
Court of Appeal Officers. PI 10942 got either Issue Denial Fraud Proof or Issue Proof + Case Closure Fraud  
Proof.

The Appeal Frauds were used for the Contempt Claim Fraud 2020 000286 Trial Frauds that got Audio  
Records that are Personal Responsibility Proof against the State Counsel and Trial Judges.

All of it is Relevant Evidence for the Fraud Appeal.
