Grounds: Fraudulent Breaches of Natural Justice + Human Rights + Overriding Justice Objective

1. The Citizen, Crown and Lord Bishops have Justice Responsibilities known as the Equity Monarchy Trusts. They have Corruption Control Jurisdictions that govern Parliament Session Powers. In 2004 they used them for a Corruption Remedy Process that has continued ever since. In 2019 it got a Forced Resignation from Prime Minister Mrs May, a Forced General Election and Parliament Session Agreement Conditions that a Royal Commission get Corruption Remedies before the Session End. Everyone involved knew that the Protection Fraud Network would use Corrupt Parliamentarians for Remedy Sabotage Frauds. The Remedy Process needed Criminal Conspiracy Proof to silence Corrupt Parliamentarians until Unfitness Cases got Corruption Findings and Dismissal Decisions against Top Judges. The Criminal Conspiracy Proof needed to meet the Corruption Remedy Proof Standard. It is Official Records that are Justice Proof for Honourable Officers or Guilt Proof against Corrupt Officers and Credibility Irrelevance Proof for the Victim. On 19th December 2019 the announcement of the Royal Commission by the Queen in the Parliament Session Opening Speech was a Remedy Process Protocol Signal for Citizens to get the Criminal Conspiracy Proof.
2. Equity Lawyer Mr Edward William Ellis helped Citizens to get Criminal Conspiracy Proof.
3. Corrupt Officers used Computer Record Frauds for Case Misrepresentation Frauds + Management Misrepresentation Frauds + Identity Misrepresentation Frauds as Protection Frauds for State Officers and Law Court Judges. The Computer Records were Forgery Proof and Perjury Proof for Parliament, the Crown and Citizen against the Ministry of Justice and the Law Courts. It created the need for Audio Records as Personal Responsibility Proof against Identifiable Individuals.
4. Corrupt Officers made Protection Fraud Demands that needed Court Frauds and Criminal Conspiracy by State Officers and Law Court Judges for Substitution Frauds of:

Justices of the Court of Appeal.

The Case Reference got a Pending Adjudication Regulation Stay Protection Rights + Remedy Only Jurisdiction Limit for the Equity Lawyer against the Officers and Masters of the Court of Appeal. Then it got Case Reference Adjudication Denial Fraud Proof + Regulation Breach Case Dismissal Fraud Proof + Justice Perversion Criminal Conspiracy Proof for the Equity Lawyer, Crown and Parliament against the Officers, Masters and Lord Justices of the Court of Appeal. The Just Adjudication Denial Fraud was a DOUBLE Contempt Fraud against the Protection Rights got by both the Restraint Renewal Fraud Appeal 2020 0396 and the Committal Trial Permission Fraud Appeal that got Pending Issue Reference 2020 10942.
9. The Committal Trial Permission Fraud Appeal Issue Delay Fraud continued until after the Imprisonment Committal Trial. On 3rd November 2020 the Trial Fraud got Protection Breach Trial Stay Protection Breach Contempt Fraud Proof + Conflicted Interest Recusal Refusal Fraud Proof that got Crime Proceeds Status for the Trial Fraud + Trial Directions Fraud on 3rd November 2020 for the Equity Lawyer, Crown and Parliament against the State, Trial Judge Mr Jay and the High Court. A Recusal Challenge outside the court room got a Forced Recusal Judgement + Reason Frauds dated 6th November 2020 and then Recusal Decision Proof + a Trial Directions Confirmation Order Frauds dated 9th November 2020 from Trial Judge Mr Jay. All of it added to the Bias Fraud Proof + Justice Perversion Criminal Conspiracy Proof against the State, him, the High Court and Court of Appeal.
