In December 2019 the Parliament Session Agreement between the Crown and Prime Minister contained Corruption Remedy Conditions. They required that a Royal Commission get Corruption Remedies before the Session End. The Default Penalty is a Parliament Session Refusal and Forced General Election with Mass Publicity for the Corruption Proof and Remedy Denial Fraud Proof. It needs Criminal Conspiracy Proof to silence Corrupt Parliamentarians until Unfitness Cases get Dismissal Decisions against Top Judges.

Prime Minister Mr Johnson made Protection Fraud Deals to win the Leadership Contest and more of them to get Propaganda Services in the 2019 General Election. He got an 80 Seat Majority. He needs Corruption remedies to keep it.

Citizens got Criminal Conspiracy Proof. Corrupt Officers made Protection Fraud Demands and tried to defend themselves with Computer Record Frauds to get Case Misrepresentation Frauds and Anonymity Frauds. Computer Records are Forgery + Perjury Proof against the Ministry of Justice and Law Courts. It created a need for Audio Records as Personal Responsibility Proof against Identifiable Individuals.

Citizen Cases got Court Hearing Audio Records and Hearing Denial Frauds to avoid Audio Records.

The Contempt Claim Fraud 2020 000286 + General Civil Restraint Renewal Fraud + Restraint Breach Contempt Imprisonment Trial Fraud against the Equity Lawyer is the Audio Record Lead Case. It forced Top Judges to choose between Conflict Disqualification Admissions and committing Conflict Qualification Frauds. Everything that could go wrong for them did go wrong. They did not know how to stop.
