Stated Reasons

1. Contempt 2020 000286 Reasons Fraud dated 18th December 2020 of Trial Judge Mrs Cutts contains:

1.1. Tautology Quotation Frauds.

1.1.1. The People need the 'Corruption Remedy Process' is to counter 'Systematic Corruption' and 'Mass Remedies' to counter 'Mass Corruption'. The Approved Judgment uses the phrase 'Mass Remedy Process' in paragraph 30.iv.a and combines the phrases to make 'mass remedy corruption process' in paragraphs 14 and 25. It is a Meaningless Phrase. A Remedy Process is the reverse of a Corruption Process. It is a Tautology Fraud. The Quotations Marks make it a Quotation Fraud. It is a Quotation Misrepresentation Fraud and a Tautology Quotation Fraud and a Communication Incapacity Defamation Fraud against Equity Lawyer Mr Ellis who is the Quoted Party.

1.1.2. The Equity Monarchy Trusts and the Remedy Process use the Corruption Remedy Proof Standard. It is Official Records that are Justice Proof for Honourable Officers or Guilt Proof against Corrupt Officers and Credibility Irrelevance Proof for the Victim. The Approved

Judgement uses the phrase “proof sets to meet the conspiracy proof standard”. The Conspiracy Proof Standard is a Liability Proof Standard. It uses the Beyond Reasonable Doubt Proof Standard. The Corruption Remedy Proof Standard is a much higher standard. It is a Certainty Proof Standard. The Quoted Phrase is a Proof Standard Misrepresentation Fraud. The Quotation Marks make it a Quotation Fraud and a Quotation Misrepresentation Defamation Fraud against Equity Lawyer Mr Ellis who is the Quoted Party.

1.2. Jurisdiction Issue Denial Frauds in paragraph 30.ii) using the words ‘No document addresses the issue in the legal proceedings in which the named person was involved.’

1.3. Independence Incapacity Misrepresentation Frauds using the words ‘It is inconceivable in my view that the named persons would have brought the proceedings individually and sought only the Respondent assistance or passed details of their case to him for collation.’

1.4. Reserved Rights for the Equity Lawyer to identify and explain More Fraud

2. The Committal Permission Fraud Appeal was filed on 22nd June 2020 and got Issue Denial Fraud Proof against the Court of Appeal.
3. The Recusal Refusal Fraud + Trial Directions Fraud Appeal and Trial Directions Confirmation Appeal Filing Event got Filing Acknowledgement Denial Fraud Proof and Issue Denial Fraud Proof against the Court of Appeal.
4. On Filing Day 173, which was Saturday 12th December 2020, the Committal Permission Fraud Appeal got issue with reference 2020 2069. On Friday 18th December 2020 the Bundle Filing Time Limit Reduction Fraud Emails, one at 10.00 gave the 21st December 2020 Filing Date and another at 14.48 gave the Noon Filing Time. They were used for an Appeal Dismissal Fraud that day.
5. Top Police, Top Customs and Top Judges were the Top Drug Dealers. They needed Chemically Traceable Drugs for Career Sabotage Frauds against Honest Officers. Sussex Police hosted the Drug Production. Corrupt Officers demanded Protection Frauds. Top Judges made Protection Fraud Promises subject to Fraud Commitment Conditions. The Corrupt Officers accepted Trial Frauds and Appeal Dismissal Fraud against the Equity Lawyer were Before Event Protection Fraud Proof. They delivered the Sex Crime Investigation Frauds for a Repeat Ruin Fraud against Citizen Mr Matthew Taylor as Fraud Commitment Proof for the Top Judges
