Royal Commission Test Case Notice for Lease Claim G00CR488

Limited Capacity Notice + Judicial Assistance Obligation Notice for Citizen Mr Serbert against the County Court. He has Limited English Literacy and has difficulty getting Interpretation Services good enough to cope with Corruption Cases.

Corruption Claim Notice for Citizen Mr Serbert against Dotcom Solicitors, Law Society and Ministry of Justice. Top Judges formed Asset Theft Partnerships with Organised Criminals, Representatives and State Officers. The Law Society provides Protection Frauds for Corrupt Lawyers. Illiterate Immigrants are Easy Targets because they cannot get Corruption Case Management from Qualified Lawyers. The Citizen, Crown and Lord Bishops have Corruption Control Jurisdictions that govern Parliament Session Powers. They managed a Corruption Remedy Process. The Parliament Session Agreement dated 19th December 2019 contained Corruption Remedy Conditions. They required Corruption Remedies before the Session End. It needed Protection Fraud Criminal Conspiracy Proof against Organised Criminals, Representatives, State Officers and Law Court Judges. Illiterate Immigrant Cases were particularly useful getting the Criminal Conspiracy Proof that the Remedy Process needed. The Land Fraud Proof Set was got by the Trust Claim Fraud B01B0837 + Mortgage Repossession Claim Fraud F01PP7696 + Protection Denial Fraud Claim 2020 000968 + Fraud Appeal 2020 0742 for Citizen Mr Sood, and the Shop Theft Claims 2019 003741 + 003984 of Citizen Mr Yediyali, and the Lease Possession Claim Fraud F02ED793 of Citizen Mr Hastunc. A Land Fraud against Citizen Mr Serbert did Consequential Damage that forced Restaurant Manager Appointments that got Accounting Refusal Frauds by them against him. The Other Illiterate Immigrant Cases got Similar Fraud Fact Proof that enabled use of the Lease Claim G00CR488 for the Consequential Damage Claim. The Royal Commission Emails has informed the G00CR488 Claimant Lawyers since 25/01/2020.

Contempt Claim Fraud 2020 000286 + 5 Fraud Appeals got Superior Jurisdiction Witness Protection Rights + Inferior Remedy Only Jurisdiction Limits for Citizen Mr Serbert against the County Court
