COURT MOTION ORDER

1. Within 7 Days Discovery Order for Citizen Mr Bradley against Respondents Mr and Mrs Faull and Response Case Management Lawyer Mr John Timothy Deacon and the Chief Executive of BMW Limited who practice as Burnand Brazier Malcolm Wilson that they file and serve Statements
 - 1.1. Explaining that they acknowledge the Court Fraud Allegations made by Citizen Mr Bradley and whether a Conflicted Interest Disqualification prevents the Case Management Lawyer Mr John Timothy Deacon and BMW Limited acting for Mr and Mrs Faull or whether they claim a Common Interest enables them to do so
 - 1.2. Responding to the Incapacity Finding + Litigation Friend Appointment Application of Citizen Mr Bradley
 - 1.3. Making Trial Direction Proposals
 - 1.3.1. To decide whether there are Special Protection Rights for Equity Lawyer Mr Ellis from the Crown and Parliament with Protection Enforcement by the Cabinet and Prime Minister and Enforcement Accountability by the Opposition Leader and if so whether they invalidate the Law Profession Disqualifications and Restraint Orders against him
 - 1.3.2. To decide whether there are General Protection Rights for Citizen Mr Bradley from the Crown and Parliament with Protection Enforcement by the Cabinet and Prime Minister and Enforcement Accountability by the Opposition Leader and if so whether they invalidate the Assessment Trial on 7th June 2019 and the Enforcement Action taken thereafter and whether the Assessment Trial and Enforcement Action are Protection Breach Contempt and if so what are Proportionate Remedies
 - 1.3.3. To decide whether there was a Valid Judgment vested Trial Powers in the County Court or Judgment Deficit invalidated the use of Trial Powers

Appeal and Application 1 Hour Hearing in Royal Court 37 at 2 pm on September 2019 with Attendance Waivers for Citizen Mr Bradley because of the Illness Incapacity and an Attendance Waiver for Citizen Mr Brooks because of the Wheel Chair Limited Access to the Royal Courts and Representation Rights for Equity Lawyer Mr Ellis
