

Election Fairness Claim Form Content of Mr Awodiya v Party Leaders + State + Media

Without Prejudice to Invalidity Arguments

The Crown and Lord Bishops have Parliament Session Powers. They are making Remedy Management Decisions for the 2019 Parliament Session. They needed Citizens to use Test Cases to discover how the Law Courts function under Prime Minister Mr Johnson.

Citizen Mr Bradley has given them the use of Nuisance Trial Fraud Appeal QA 2019 000205 + Connected Cases. They forces Law Court Judges to decide what to do with:

- 1. Incapacity Proof + Incapacity Remedy Denial Fraud Proof + Conspiracy Proof + Contempt Proof + Incapacity Finding and Incapacity Remedies and Litigation Friend Appointment Applications*
- 2. Judgment Deficit Proof + Trial Jurisdiction Fraud Proof + Conspiracy Proof + Contempt Proof + £392,260.42 Damage Assessment and Costs Appeal + Revocation Applications*

In August 2019 Citizens Mr Bradley and Mr Brooks and Others used Corruption Claims + Election Fairness Claims as Test Cases and got Issue Denial Fraud Proof against the High Court. The Refusal Reasons include:

- 1. No Disclosed Reason [Corruption Claims of Citizens Mr Bradley and Mr Brooks]*
- 2. Inclusion of the Party Details in the Claim Form instead of Party Details on a Separate Sheet*
- 3. Omission of Christian Names from the Party Identifications: Prime Minister Mr Johnson + Attorney General Mr Cox + Opposition Leader Mr Johnson*
- 4. Hand Written insertion of the Christian Names: Boris + Geoffrey + Jeremy instead of a New Typed List*
- 5. The Receipt Stamp Proof from the Crown Prosecutor on Case Papers that evidence they are on the Remedy Process File held by the Director of Public Prosecutions for the Crown and Prime Minister*

The Crown and Lord Bishops have Parliament Session Powers. They use the Corruption Remedy Proof Standard. It is Official Records that are Justice Proof for Honourable Officers or Guilt Proof against Corrupt Officers and Credibility Irrelevance Proof for the Victim. They have made Corruption Findings and Unfitness Findings and Mass Remedy Entitlement Findings and are making Remedy Priority Decisions for the 2019 Parliament Session. Citizens are using Test Cases to discover how the Law Courts function under Prime Minister Mr Johnson and to get Unviable Condition Proof he can use to get Obligation Releases from Protection Fraud Promises he made to get Leadership Support.

The Politicians are preparing for a General Election. Mr Awodiya is preparing to stand as an Independent Candidate with a Corruption Remedy Campaign using the Common Law and Personal Accountability. Corrupt Officers are using Police Powers and Local Authority Powers and Law Court Powers for Intimidation Frauds to deter him from standing as an Independent Candidate to get a Remedy Mandate

Mr Awodiya is not the first Corruption Remedy Candidate. In April and May 2019 Mr Adam Mustafa did Election Research. He stood as an Independent Candidate for the Crewe Central Ward of Cheshire Council with a Corruption Remedy Campaign. He campaigned for the Justice Priority Obligation and the Common Law and against Politically Correct Race Bias Frauds. More than 50 Years Political Correctness got a Racial Prejudice Complaint Process Denial Fraud + Racial Prejudice Prosecution Fraud + Video Innocence Destruction Frauds + Video Perjury Evidence Destruction Fraud for a White Person against him. The Cheshire Law Courts needed to avoid a Not Guilty Plea + Jury Trial Jury + Bias Fraud Defence + Innocence Evidence Destruction Bias Fraud. They used Defence Case Sabotage Frauds by the Defender. He ignored Defence Instructions and made an Unauthorised Plea Bargain. Mr Mustafa protested, discovered the Corruption Remedy Process and used his case to service it. The Protection Fraud network responded with Firearms Investigation Frauds + Mental Health Frauds + Forced Medication Frauds as Discredit Frauds and Intimidation Frauds. They failed. The Audio Records are Trial Fraud Blackmail Proof against the Prosecutor + Trial Judge + Crown Court Resident Judge. The Election Campaign got Campaign Sabotage Fraud Proof for him against the Labour Party + Others

It is Similar Fact Election Fraud Proof for Mr Awodiya. He is black. He made Child Disability Claims that got a Disability Budget for His Disabled Child at Alwoodley Primary School, Leeds + Budget. Allocation Fraud + Disability Service Denial Fraud by the School against the Disabled Child, He made Corruption Complaints that got the Co-ordinated Corruption of Firearms Possession Defamation Frauds + Firearms Record Employment Sabotage Frauds + Dangerous Personality Defamation Frauds by West Yorkshire Police + House Repair Denial Frauds + Eviction Blackmail Intimidation Frauds + Child Protection Blackmail Frauds + Electronic Surveillance Frauds + by Leeds City Council using the Border Agency and Neighbours as Agents + Case Management Frauds by the Ministry of Justice and Law Courts. The Firearms Possession Defamation Frauds + Violent Personality Defamation Frauds enabled Violent Force Frauds by Police against Mr Awodiya.

Police Harassment Frauds forced him into hiding. This Election Fairness Claim will get Protection Justice Proof for Party Leaders + Law Courts or Election Corruption Proof against them. The Crown and Lord Bishops can use it when making Corruption Remedy Decisions for the 2019 Parliament Session
