Remedy Process + Judicial Office Unfitness Cases + Election Fairness Issue Denial Fraud 2nd September 2019

Contempt and terrorism Penalty Warning to Officers + Masters + Justices of the High Court

The Citizen, Crown and Lord Bishops have Corruption Control Jurisdictions that govern Parliament Session Powers. The Ultimate Sanction is a Parliament Session Refusal and Forced General Election with Mass Publicity for Corruption Proof and Remedy Denial Fraud Proof. They have managed a Corruption Remedy Process that got Criminal Conspiracy Proof against Top State Officers and Law Courts Judges. They used it to decide the Corruption Remedy Conditions for the 2017 Parliament Session Agreement. They needed a 2 ½ Year Session for Remedy Management. It got Criminal Conspiracy Proof against Corruption Controllers. It was used for Judicial Office Unfitness Case Notices to Parliament. They put the Unfitness Cases in parliament and enabled Protection Fraud Investigations by the Crown, Lord Bishops and Honourable Members. They got Criminal Conspiracy Proof against Corrupt MPs, Attorney General Mr Cox, Prime Minister Mrs May and Opposition Leader Mr Corbyn and a Forced Resignation by Prime Minister Mrs May Prime Minister Mr Johnson made Protection Fraud Deals with Corrupt MPs in exchange for Leadership Support. Attorney General Mr Cox is the Protection Fraud Co-ordinator in Parliament for the Protection Fraud Network. The Protection Deals are subject to Viable Execution Conditions. Citizens are not surprised that the Prime Minister got Mass Publicity for Prorogation Advice he gave to the Crown. They will not be surprised if gets Mass Publicity for a Formal Request to the Crown for a Parliament Session Refusal and Forced General Election with Mass Publicity for the Corruption Proof and Remedy Denial Fraud Proof.

Citizens are using Corruption Remedy Claims and Election Fairness Claims as Test Cases

1. To get Unviable Conditions Proof the Prime Minister can use for Fraud Promise Releases.
2. To discover how the Law Courts function under Prime Minister Mr Johnson

In August 2019 the Test Cases got Issue Denial Fraud Proof + Remedy Application Denial Fraud Proof against the High Court. The Election fairness Claims gave Liability Defendant Status to Prime Minister Mr Johnson and Opposition Leader Mr Corbyn and the Other Party Leaders. The Fraud Proof gets a Proof Burden Reversal for the Victim against All Others subject to Rebuttal Proof. The Only Credible Rebuttal Proof will be Full Co-operation by the Party Leaders managing Mass Remedies before the General Election.

Citizen Mr Franklin Awodiya is a Corruption Refugee of No Fixed Abode with the Court Correspondence Address of 450 New North Road, Hainault IG6 3EB. On 2nd September 2019 Citizen Mr Awodiya got Fee Remission Certificates for an Election Fairness Claim and Remedy Application before a High Court Justice. he got Issue Denial Fraud Proof against the High Court Actions Officers. He insisted on Receipt Proof for the Claim Form Fee Remission Certificate + Claim Form They refused to give it. They wanted to know what the case was about. They took the Application Fee Remission Certificate + Application Notice + Draft Order deleted 'Justice' and inserted 'Master' on the Application Notice and him Stamp Filing Proof on his Application Notice + Draft Order. A document entitled Claim Form Content was filed QA 2019 000205 and Stamp Filing Proof got from the High Court Appeals Office on Multiple Originals. He intends to file the Claim Form + Claim Form Content Document + This Statement and ask for a Filing Receipt tomorrow.
