Contempt and Terrorism Penalty Warning

The Crown and Lord Bishops are making Corruption Remedy Decisions for the 2019 Parliament Session. The Ultimate Sanction is a Parliament Session Refusal and Forced General Election with Mass Publicity for the Corruption Proof and Remedy Denial Fraud Proof. It needs a Validation Proof Set and a Publicity Proof Set.

The Validation Proof Set is everything a Corruption Remedy Process has got since it started in October 2004.

The Publicity Proof Set needs Top Judges caught Red Handed with Court Frauds and Corruption Remedy Issue Denial Frauds and Election Fairness Claims.

The Nuisance Trial Frauds E08YJ260 and the Trial Fraud Appeal QB 2019 000205 of Citizen Mr Bradley v Mr and Mrs Faull is one of the Caught Red Handed Court Frauds. They have provided Criminal Conspiracy Proof against Corrupt State Officers, Mr and Mrs Faull, Their Representatives and Law Court Judges. It includes Corruption Proof got by the Harassment and Assault Framing Fraud Trial + Appeal 2015 0156.

The Corruption Remedy Process needed the Nuisance Case E08YJ260 to get an Audio Record of the Hearing Management by the Claimant Lawyers and Judge Venn after they had notice of the Appeal Case and the Corruption Case Incapacity Finding + Litigation Friend Appointment Application with Equity Lawyer Mr Ellis and Citizen Mr Brooks identified as the Litigation Friends.

On Friday 6th September 2019 the Nuisance E08YJ260 Title Charge Hearing of Mrs and Mrs Faull and a Remedy Application of Citizen Bradley got the Audio Record and much more. Citizen Mr Bradley did not attend. Equity Lawyer and Citizen Mr Brooks did attend. The Equity Lawyer arrived at about 9.30. The Hearing List omitted the Case Hearings. The Equity Lawyer asked for a print of the Hearing List as Hearing Omission Proof and got a Print Refusal. He asked whether it was listed for hearing anywhere else. The Court Officer said there was No Diary Entry. The Equity Lawyer asked for Stamp Filing Proof on the Case Proposals and got a Stamp Filing Refusal. He stood by the Hearing List and made notes of the content. He had not finished doing so when at 10.10 the Court Officers used a No Valid Business Reason for a Court Building Eviction Fraud against the Equity Lawyer. Meanwhile, Citizen Mr Brooks arrived at 09.45 and was directed to the Hearing Venue. Judge Venn sat made a Hearing Denial Order against Citizen Mr Brooks, read out some of the Remedy Process Documents produced by the Equity Lawyer, claimed she did not understand them, made Contempt Prosecution Threats against Citizen Mr Brooks and then and asked him questions.

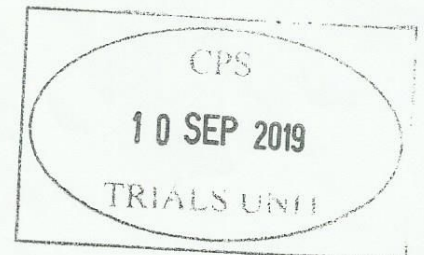
