Evidence Notices

Citizen Mr Bradley delivered the Appeal Grounds and Appellant Notice to Brighton County Court. It got a Receipt Stamp + Handwritten Note 'No fee enclosed' on the Grounds and return of the papers with the £140 Fee Notice dated 25th September 2019. It Appeal Jurisdiction Fraud Evidence against the County Court.

The Illness Incapacity Opinion Request failed to get a Response or Opinion from the GP

The Assault + Harassment Trial Fraud Appeal New Evidence Notice got no response from Sussex Police

The Charging Order Notice got a Borrowing Rights Revocation by Mortgagees against the Citizen. It evidences the Nuisance Claim got a Trial Fraud + Damage Fraud + Payment Capacity Denial Fraud.

All of it is Relevant Evidence for Aggravated Damages + Exemplary Damages + Deterrent Penalties

Citizen Mr Bradley has made a valuable contribution to Corruption Stress Research + Recovery Research that is likely to get Significant Savings for the National Health Service.

Total Immunity Forfeit Notice

The Corruption Remedy Process has been long and complicated. Corruption Investigations got Proof Sets. The Crown and Lord Bishops used them to make Remedy Decisions. One of the decisions was for the use of Court Fraud Proof as Terrorism Proof and use of that for Asset Forfeiture.

The Remedy Process got Remedy Co-operation from USA Presidents Mr Obama and Mr Trump. The result is Disclosure Arrangements with Tax Haven Jurisdictions. The Paradise Papers Publicity gave notice to Organised Criminals there is No Tax Haven for Terrorist Assets.

The Remedy Process will use Deterrent Precedents. They will include Total Asset Forfeitures against Organised Criminals, Corrupt State Officers and Law Court Judges.

Limited Immunity Negotiation Offer

Mr and Mrs Faull have 7 days to negotiate with Equity Lawyer Mr Ellis the exchange of Limited Immunity for Remedy Co-operation that includes Full Disclosure about All Corruption Services provided by the State and Law Courts. Conflict Disqualification prevents the Attorney General and Solicitor General conducting the negotiations. Any response, or lack of it, will be Relevant Evidence when the Crown and Lord Bishops make Remedy Decisions for the 2019 Parliament Session.
