The circumstances

Mr and Mrs Awodiya live at 49 King Alfred Road, Leeds. They are Corruption Whistle Blowers. Mr Awodiya is a Corruption Refugee from Local Corrupt Officers but not from the Secret Service.

Mr and Mrs Awodiya got a Special Education Budget for a Disabled Child. It got a Service Denial Fraud Proof + Budget Fraud Proof against a Local School. They made Budget Fraud Complaints. The Local Corrupt Officers responded with Ruin Frauds against Citizen Mr Awodiya. It started with Firearms Possession Defamation Frauds and Violent Personality Defamation Frauds by the Police. Mr and Mrs Awodiya got Corruption Proof at every stage of the process. The Corrupt Officers were angry.

Mr and Mrs Awodiya learned about the Equity Monarchy Trusts and use of them for a Corruption Remedy Process. The Equity Monarchy Trusts are Justice Responsibilities of the Citizen, Crown and Lord Bishops. They have Corruption Control Jurisdictions that govern Parliament Session Powers. The Ultimate Sanction is a Parliament Session Refusal and Forced General Election with Mass Publicity for the Corruption Proof and Remedy Denial Fraud Proof. The Ultimate Sanction enables the imposition of Corruption Remedy Conditions in Parliament Session Agreements between the Crown and the Prime Minister. The Equity Monarchy Trusts fell into disuse for 45 years when the Politicians developed Dictator Powers. In 2004 the European Leaders wanted Referenda Acceptance of Dictator Powers. They committed Election Frauds to get it. The Fraud Proof was used for a Corruption Notice to the Crown and Parliament. It revived use of the Equity Monarchy Trusts. It started a Corruption Remedy Process that has continued ever since. In 2006, 2007 and 2017 the Ultimate Sanction Threat was used to get a Forced Resignation by Prime Minister Mr Blair, the imposition of Corruption Remedy Conditions on Prime Minister Mr Brown and the Surprise General Election by Prime Minister Mrs May. The Crown and Lord Bishops needed an Election Free Period to enable a Long Session of 2 ½ years for Remedy Management. They needed it to destroy a Protection Fraud Network. Corrupt MPs protected Corrupt Judges who protected Corrupt State Officers who protected Organised Criminals. The Surprise General Election got the Long Session. It is near an end.

The Corruption Remedy Process needed Election Fairness Claims with Defendant Status for Political Party Leaders. Mr Awodiya got issue of Election Fairness Claim QB 2019 003126. He used it for Corruption Remedy Applications. The Local Corrupt Officers are desperate. They delude themselves that they need Repeat Police Harassment Frauds. They could not be more wrong.
