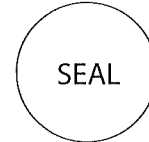

Human Rights Brach Frauds 1,2,3,4,5,6,7,8,9,10,11,12,13 Bias + Torture + Fraud

In 2006 a Disabled Student made a Sex Complaint against a Teacher. Competent Investigation would expose Powerful Paedophiles. Everyone knew it would get Competent Investigation from Head Master Mr Pead. The Powerful Paedophiles used Employment Termination Frauds to stop him conducting a Competent Investigation. He got Fraud Proof against the Employment Officers. They made Protection Fraud Demands and were given a Family Sabotage Fraud + Life Ruin Fraud that used an Invented Identity Fraud + Sex Crime Complaint Fraud + Investigation Fraud + Prosecution Fraud + Trial Fraud + Conviction Fraud + Sentence Fraud + Restraint Fraud. The Restraint Fraud was an Obvious Fraud because it used Restraint Powers the Crown Court did not have. The Record Frauds were used for Repeat Trial Frauds. Corrupt Officers lost the confidence in Protection Frauds by Corrupt MPs and Law Court Judges. They used Total Destruction of the 1st Trial Fraud Records to get Protection Frauds. The Norfolk Authorities used the Obvious Restraint Fraud for the Restraint Breach Enforcement Trial Fraud 2017 0471. It was the 7th Trial Fraud. On 15th July 2019 in Norwich Crown Court the Trial Audio Record contains Restraint Order Invalidity Admissions by Trial Court Judge Ms Bacon. She failed to make a Contempt Finding + Contempt Investigation Order + Remedy Orders + Case Dismissal Order for the Citizen against the State. She used Case Orders for Remedy Delay Frauds. On 11th October 2019 the Trial Fraud 2017 0471 got an Audio Record that is Criminal Conspiracy Proof against the Crown Prosecutor and Trial Judge of Trial Fraud Blackmail + Leniency Bribery to extort a Guilty Plea. It failed. On 29th October 2019 the Criminal Trial Fraud Appeal 2018 00198 Permission Hearing was listed in Royal Court 8. Equity Lawyer Mr Ellis gives evidence that Appeal Lord Justice Mr Irwin + High Court Justice Ms Andrews have Conflicted Interests and committed Conflict Qualification Frauds + Recusal Failure Frauds to keep Case Control needed for the Appeal Permission Refusal Frauds that were Protection Frauds for All Relevant Officers. The Conflict Disqualification against Appeal Lord Mr Irwin includes the Cancer Treatment Denial Fraud Hospital Murder Cover Up 2011 Review Permission Refusal Fraud against Shropshire Farmer Mr Charles Sydney Ellis. He used the case to service a Corruption Investigation of the Law Courts by Lord Chancellor MP Mr Clarke for the Crown. The Conflict Disqualification Fraud Proof against High Court Justice Ms Andrews includes the Election Fairness Claim QB 2019 003126 Dismissal + Restraint Frauds dated 14th October 2019 against Citizen Mr Awodiya.
