Law Practice Intervention Application by Citizen Mr Bradley v All Lawyers at Burnand Brazier Malcolm Wilson

The circumstances

The Citizen, Crown and Lord Bishops have Justice Responsibilities known as the Equity Monarchy Trusts. They have Corruption Control Jurisdictions that govern Parliament Session Powers. The Ultimate Sanction is a Parliament Session Refusal and Forced General Election with Mass Publicity for the Corruption Proof and Remedy Denial Fraud Proof. It needs a Validity Proof Set that can be complicated and a Publicity Proof Set that every Voter can understand.

The Citizen, Crown and Parliament managed Corruption Investigations of the State, Profession Authorities and Law Courts. Secret Service Officers assisted by setting up conditions for Integrity Tests of the Law Courts.

Organised Criminals wanted 4 houses for a property development. Citizen Mr Bradley had one of the Middle Houses. The Organised Criminals used Harassment Frauds against Citizen Mr Bradley with intent to get a Forced Sale. The Harassment Frauds included Nuisance Complaint Investigation Denial Frauds + Early Morning Noisy Dust Bin Collection Harassment by Brighton and Hove City Council and Harassment Criminal Prosecution Frauds + Conviction Frauds by Sussex Police + Crown Prosecutors + Defenders + Trial Judges + Appeal Judges and Nuisance Claim Fraud E08YJ260 by Organised Criminals Mr and Mrs Faull. It was Co-ordinated Corruption. It was noticed.

Secret Service Officers used Nuisance Claim E08YJ260 for an Integrity Test of the Claim Lawyers and Trial Judges. They produced a document entitled 'Judgment for Claimant' with Decision Date and Print Date 16th May 2018 that did not contain a judgment. It contained the words 'ther directions/arrangements for that decision to be made will be sent to all parties shortly. Date: 16 May 2018'. The words were put on the document so that Judgment Forgery needed the Double Forgery of a Quoted Words Deletion and a Judgment Words Addition. The Test Document was Judgment Deficit Proof and Trial Power Deficit Proof.

Due Process required the Test Document to be placed before Junior Trial Judges to decide whether it was Judgment Proof and Trial Powers Entitlement Proof. Investigation is needed to discover what happened to the Test Document between 16th May 2018 and 4th July 2018 when it was placed before South East Top Civil Judge Mr Simkiss. He had Appeal Jurisdiction. It was a 1st Instance Trial Jurisdiction Disqualification. He committed a Conflict Disqualification Fraud to get the Case Control needed to make the Trial Jurisdiction Finding evidenced by the Trial Direction Hearing Listing Order dated 4th July 2018 with Print Date 1st August 2018. The Test Document and the Trial Direction Hearing Listing Documents are numbered 65 and 67 in the Trial Bundle produced by Claim Lawyer Mr Timothy Deacon for Bunand Brazier Malcolm Wilson. The Claim Lawyers and Trial Judges committed Trial Frauds that got the £292,260.42 Exemplary Damage Award + Costs Order dated 7th December 2019 and Enforcement Frauds thereafter. The Fraud Appeals QA 2019 000205 + 000265 got Appeal Permission Denial Frauds + Restraint Frauds against Citizen Mr Bradley. He will appeal. Sussex Police used Uniformed Officers for Personal Service of Civil Case Papers in the Late Night and Early Morning. There is Resource Allocation Fraud Proof against Top Officers in Sussex Police

Election Fairness Claims gave Liability Defendant Status to Political Party Leaders. Most got Issue Denial Fraud Proof. QB 2019 003126 got Fraud Revocation Applications + Fraud Appeals QA 2019 000296 + 2019 2700 in the High Court and Court of Appeal. The choice is Fraud Remedies for the Victims or Fraud Liabilities for the Party Leaders
