Fast Food Recovery Business QB 2019 003741 Test Case Notice + Immunity Negotiation Offer

Choice: An Immunity Deal or Joint Criminal Liability for Top Level Election Frauds

A Corruption Remedy Process got Criminal Conspiracy Proof against Corruption Controllers and Dismissal Cases against Top Judges in Parliament. It enabled Protection Fraud Investigations in Parliament that got Corruption Proof against Media Managers and Many MPs including Attorney General Mr Cox, Prime Minister Mrs May and Opposition Leader Mr Corbyn. It includes Publicity Bias Frauds for the Brexit Issue against the Corruption Issue. The Remedy Process got a Forced Resignation from Prime Minister Mrs May. The Leadership Contestants made Protection Fraud Deals to get Leadership Support and a Forced General Election. They Protection Fraud Deals were subject to Viable Execution Conditions. Citizens used their cases to get Unviable Conditions Proof that enabled Deal Obligation Releases

Corruption Claims and Election Fairness Claims got Issue Denial Fraud Proof and Remedy Denial Fraud Proof against the High Court and Court of Appeal. The Election Fairness Claims gave Liability Defendant Status to the Political Party Leaders, State and Media. The Issue Denial Frauds were Election Frauds.

The Corruption Claims of Citizen Mr and Mrs Awodiya got Criminal Conspiracy Proof against State Officers, Government Lawyers and Law Court Judges. The Perjury Proof and Forgery Proof against the Government Lawyers include Law Profession Registration Denial Frauds and Back Dated Email Frauds. The Perjury Proof and Forgery Proof against West Yorkshire Police and Crime Commissioner include use of a Complaint Record Forgery for a Complaint Dismissal Fraud. The Perjury Proof and Forgery Proof against the Law Court Judges include Racial Discrimination Jurisdiction Denial Frauds and Recusal Refusal Frauds and Trial Denial Frauds. The Election Fairness Claim of Citizen Mr Awodiya got issue as QB 2019 003126 and Dismissal Frauds and Restraint Frauds and Appeal Frauds. All of it is Election Fraud Proof for the Citizen, Crown and Parliament against the Law Courts and the Party Leaders and Media Managers. The Election Fraud Appeal 2019 2700 is in the Court of Appeal. The Election Fairness Case will get Remedy Co-operation Proof for the Media and Party Leaders or Election Fraud Proof against them.

On 30<sup>th</sup> October 2018 a Crown Court Judge sat for a Harassment Trial. He noticed Innocence Evidence Concealment Frauds. His Trial Management got an Acquittal by the Jury. He gave Claim Advice for Citizen Mr Yediyali against the Metropolitan Police, Crown Prosecutors and Defenders. The Fast Food Business Recovery Claim QB 2019 003741 of Citizen Mr Yediyali is £150,000 Damage Mitigation Initiative that prepared for Corruption Damage Claim QB 2019 003984. He filed Remedy Applications in Both Cases. They forced High Court Masters to choose between Business Accounting + Sale Price Payment Orders for Citizen Mr Yediyali that would get a £150,000 Damage Reduction for the Justice Ministry or Unjust Enrichment Frauds for the Buyers. They chose the Unjust Enrichment Frauds.

President Obama and President Trump helped the Corruption Remedy Process. The Fast Food Business Case of Citizen Mr Yediyali discovered Corrupt MPs used Top Judges and Top Police to sell Protection Frauds to Drug Dealers who financed the Kurdish PPK. Enquiries of USA President Trump might discover what influence Protection Frauds Sales by British MPs had on the decision for US Troops Withdrawal from Syria.
