Integrity Test Case Notice Election Fraud Claim Particulars

19<sup>th</sup> November 2019*Best Advice:**Claim Issue by High Court Masters + Urgent Remedy Application Hearings in Royal Court 37 by High Court Justices*

1. A Defamation Fraud Complaint to Facebook got a Defamation Remedy Refusal pending a Court Order. This Claim is to get Defamation Fraud Remedies and Election Fraud Declaration + Repeat Parliamentary Election for Mr Mustafa and the Nantwich and Crewe Constituency against the Labour Party and Parliamentary Candidate Ms Laura Smith
2. The Citizen, Crown and Lord Bishops have Justice Responsibilities known as the Equity Monarchy Trusts. They have Corruption Control Jurisdictions that govern Parliament Session Powers. They managed a Corruption Remedy Process. In April 2017 it got criminal Conspiracy Proof against Top State Officers and Law Court Judges. The Crown and Lord Bishops used it to decide the Corruption Remedy Conditions for the Parliament Session Agreement. Prime Minister Mrs May called a Surprise General Election to avoid a Parliament Session Refusal and Forced General Election with Mass Publicity for the Corruption Proof and Remedy Denial Fraud Proof. It enabled a Long Session of 2½ years for Remedy Management. Court Cases got Criminal Conspiracy Proof against Corruption Controllers for Judicial Office Unfitness Cases against Top Judges that enabled Protection Fraud Investigations in Parliament. It got Corruption Proof against Many MPs including Attorney General Mr Cox, Prime Minister Mrs May and Opposition Leader Mr Corbyn. It got a Forced Resignation from Prime Minister Mrs May and a Forced General Election.
3. From 2014 to 2018 Mr Mustafa was a Labour Party Supporter, then Worker and then Officer. The Labour Party Work caused Mr Mustafa to join the Facebook Group known as Crewe TV On Demand is a Local News Group. It has about 20,000 Members which is about 1/3<sup>rd</sup> of the Local Constituency.
4. In Mid 2015 Mr Mustafa got a Heavy Goods Vehicle Driving Licence. On 14<sup>th</sup> June 2016 Mr Mustafa was driving. Cheshire Police stopped him, committed an Arrest Fraud, discovered he had a Heavy Good Driving Licence, and then used a Breathalyser Refusal Arrest Fraud and Disobedience Arrest Fraud for a Custody Fraud. The Police Station Breathalyser Test revealed No Alcohol. They committed a Test Result Denial Fraud. The Full Disclosure + Corruption Complaint by Mr Mustafa got a Representation Refusal by Duty Defence Lawyer Mr Birch. The Police continued with a Breathalyser Refusal + Obstruction Framing Fraud Charges. It terminated his Heavy Goods Vehicle Driving Employment and started a Long Term Unemployment. The Framing Fraud got a Conviction Fraud.
5. In 2017 Mr Mustafa was a General Election Campaign Worker for Crewe and Nantwich Constituency Labour Candidate Ms Laura Smith. It is a Marginal Constituency. Mr Mustafa helped her to win it with a 48 Vote Majority.
6. In November 2017 a Racial Complaint Investigation and a Racial Complaint Investigation Denial Fraud for a White Petrol Station Manager against the Black African Mr Mustafa was Bias Fraud Proof against the Cheshire Authorities. Nothing stopped them. They had a Racial Criminal Trial against a Black Man who had a Racial Prejudice Defence and the Bias Fraud Proof. They used Defence Sabotage Frauds, Mental Illness Diagnosis

Integrity Test Case Notice Election Fraud Claim Particulars

Discredit Frauds + Mental Illness Custody Intimidation Frauds, Trial Fraud Blackmail and Leniency Bribery by the Prosecutor, Defenders and Trial Judges to extort a False Guilty Plea. The Crown Court Hearing Audio Records were Fraud Proof against the Prosecutor and Trial Judges.

7. On 23<sup>rd</sup> February 2018 Mr Mustafa and Mr Nicholas Clarke visited Equity Lawyer Mr Ellis. Mr Mustafa agreed use of his cases for the Corruption Remedy Process. They made a Case Explanation Statement that Mr Mustafa signed in the early hours of Saturday 24<sup>th</sup> February 2018. Mr Mustafa and Mr Clarke left the Meeting House. Two Metropolitan Police Officers in Plain Clothes were waiting in a Black Car for Mr Mustafa to leave the Meeting House. They did not introduce themselves as Police Officers. They pretended to be Neighbourhood Watch Residents. They started a Police Interrogation from which it was obvious they were Police Officers. Mr Mustafa used a No Legal Status Reason for an Engagement Refusal. They went to the Black Car and made a Support Call that got a Police Van within seconds. The Police Officers spoke to the Alleged Residents. Mr Mustafa and Mr Clarke got in the car. Mr Mustafa plugged his Mobile Phone into the car to get power for Recorded Exchanges with the Police Officers and Immediate Internet Publicity. He had the Driver Window slightly open. He asked Police Identification which they provided. He asked an Event Validity Explanation that they could not provide. Mr Mustafa asked Stop Questions about the Alleged Residents. The Police Officers revealed they had Previous Contact with the Alleged Residents. Mr Mustafa used the Stop Event against him and the Release Event for the Alleged Residents for a Bias Fraud Allegation against the Police Officers. The Police Officer made Repeated Efforts to get Mr Mustafa to get out of the car to Talk. Mr Mustafa said they could talk through the Slightly Open Window. During the contact Status Disclosure Requests whether they were Free or Arrested got Status Disclosure Refusals by the Police Officers. The Police Officers pretended it was a Criminal Offence to use a Stationary Car as a Mobile Phone Charger. An Immediate Superior Identity Disclosure Request by Mr Mustafa got a Disclosure Refusal by the Police Officers. The Police Officers lost the confidence for an Arrest Fraud and gave a Free Status Confirmation. Mr Mustafa stayed with Mr Clarke that night and travelled to Crewe the next morning.
8. Mr Mustafa stood in front of the offices of Defence Lawyers Pole Alcock of Crewe and made a Blog Recording about the Racist Defence Sabotage Frauds and the Murder + Human Organ Thefts against 5 Month Old Baby Sunaina Chaudhari in 2000. He gave it Internet Publicity that day. On the evidence available the Local Labour Party Officers made a Secret Rejection Decision against Mr Mustafa. They did not know how to manage it. Email Service of the Case Explanation Statement by Equity Lawyer Mr Ellis on Sunday night was noticed by the Government Lawyers on Monday morning. On Tuesday night Cheshire Police used a Firearms Investigation Fraud for an Arrest Fraud + Custody Fraud + Mental Illness Case Reference Fraud to East Cheshire Council and the Health Ministry who committed Mental Illness Custody Frauds + Forced Medication Fraud.
9. A Contempt Fraud Investigation is needed to discover what influence the Blog Publicity and Labour Party Officers and Case Explanation Statement and Government Lawyers had on the Forearms Harassment Frauds against Mr Mustafa.
10. When in Mental Health Fraud Custody Mr Mustafa wrote Mental Health Fraud Complaint Letters to Nantwich and Crewe MP Ms Laura Smith, Tottenham MP Mr David Lammy and Opposition Leader Mr Jeremy Corbyn

19<sup>th</sup> November 2019

11. In January 2019 Mr Mustafa began to get Irregular Employment as a Building Labourer. He took every opportunity to acquire Building Skills.
12. In April 2019 Mr Mustafa offered to stand as Labour Candidate for the Crewe Central Ward of Cheshire Council. The Local Labour Party used Misrepresentation Frauds and Non-Disclosure Frauds to deceive Mr Mustafa into believing he was the Labour Party Candidate until after Candidate Declaration Closure Day. On the 2<sup>nd</sup> to last day the filing of Independent Candidate Papers for Mr Mustafa got a Labour Party Expulsion Decision against him.
13. Mr Mustafa agreed to conduct Election Research for the Corruption Remedy Process. He got Election Sabotage Fraud Proof. On 5<sup>th</sup> May 2019 a 17.5% turnout got 29 Rejected Votes + 738 Accepted Votes with 450 for the Labour + 139 for Conservative + 94 for Liberal Democrat + 55 for Independent Candidate Mr Mustafa. In May 2019 he had enough Building Skills to get Ground Work Subcontracts. He seized every opportunity to acquire Business Administration Skills.
14. It became obvious to MPs that the Remedy Process would get a Forced General Election. The Nantwich and Crewe is a Key Marginal Constituency. The 55 Votes Council Seat Minority for Mr Mustafa exceeded the 48 Votes Parliament Seat Majority for Labour MP Ms Laura Smith. Mr Mustafa was building the Ground Works Business. He could not cope with Total Commitment to an Election Campaign. He could give Partial Commitment that might take 500 Labour Voters and enable Conservative Majority. He would have accepted a Dispute Settlement with a Public Apology from the Labour Parliamentary Candidate in exchange for a No Competition Commitment. Some of the Local Labour Party Officers are Power Obsessed. They have No Grasp of Goodwill Relating. They focus on Competition Sabotage. The result is a Self Destructive Culture. The cycle is New Membership followed by Relationship Stress and Gradual Disaffection. They did not make Parliament Candidacy Enquiries of Mr Mustafa. They made a Candidacy Presumption and decided to use Defamation Frauds + Police Harassment Frauds as Candidacy Sabotage Frauds against him.
15. The Ward Representation Conditions for Councillors includes 1 Year Local Employment or 1 Year 3 Mile Radius Residency and Voter Registration. A Facebook Post at 11.52 on 30<sup>th</sup> September 2019 for a Labour Party Private Group by Crewe West Ward Councillor Ms Tess Keefe revealed that she was moving about 8 miles from Crewe to Middlewich. At 21.42 on 13<sup>th</sup> October 2019 the Crewe West Former Labour Councillor Natasha Maroni sent to Mr Mustafa a Screen Shot of the Private Group Post with a Question that related to Previous Competition Sabotage. That night Mr Mustafa used the Screenshot + Question for a Facebook Post on the account Adam Mustafa for Crewe Central with a comment that the Residency Change Publicity Failure was a Transparency Failure by the Labour Party. It got a Rapid Response. The Facebook Identities known as Emma Louise Hadaway and Jennifer Mellor used the Facebook Account known as Adam Mustafa for Crewe Central and made entries that were Defamation Frauds against Mr Mustafa and Support Propaganda for Labour Parliamentary Candidate Ms Laura Smith. Mr Mustafa took an Entry Screen Shot and made a Block Decision against them. The next day they used the Facebook Groups known as Crewe TV On Demand + Crewe TV 2 + Another Group for Paedophile Defamation Frauds + Mental Illness Defamation Frauds as Parliamentary Candidacy Sabotage Frauds against Mr Mustafa.

16. Defamation Fraud Complaints to the Group Administrators that got a Block Decision against Mr Mustafa. Defamation Fraud Complaints to Facebook got a Remedy Refusal pending a Court Order. A Defamation Fraud Complaint to Cheshire Police got on the 3<sup>rd</sup> day a Complaint Enquiry Call from Officer PC Clare Owen 4538 who made a Complaint Registration Decision. It got on the 15<sup>th</sup> Day an Interview Appointment Call from PC Wood 5641 and an Interview Appointment Fixture for 1<sup>st</sup> November 2019 because that was the earliest time both of them were available.
17. Mr Mustafa prepared for the Interview Appointment. He made a Telephone Call and gave a Recorded Call Notice. It got a Call Reference to Head Secretary Ms Susan Brookfield and asked for a copy of a Mental Health Custody Fraud Complaint Letter he had sent to MP Ms Smith. It got a Disclosure Refusal and an Internet Publicity Prosecution Threat by Head Secretary Ms Susan Brookfield. Mr Mustafa used the Telephone Recording for Internet Publicity. The Labour Party made a Malicious Communication Complaint that got a Compliant Priority Bias Fraud + Harassment Frauds + Discredit Frauds + Crime Reference Denial Frauds for the Labour Party and Labour Parliamentary Candidate Ms Laura Smith against Mr Mustafa.
18. The Remedy Process needed Integrity Tests of the Media, State, Law Courts and Top Politicians before and during the General Election Campaign Period. Citizens used Corruption Claims and Election Fairness Claims for Integrity Tests. They got Issue Denial Fraud Proof, Remedy Denial Fraud Proof and Election Fraud Proof for the Citizens, Crown and Parliament against the Media, State, Law Courts and Top Politicians.
