TAKE NOTICE that:

1. The Citizen Crown and Lord Bishops have Justice Responsibilities known as the Equity Monarchy Trusts. They have Corruption Control Jurisdictions that govern Parliament Session Powers. They have managed a Corruption Remedy Process. It got Criminal Conspiracy Proof against Top State Officers and Law Court Judges. In 2017 the Crown and Lord Bishops used it get a Forced General Election and Long Session for Corruption Investigations of the Law Courts and Parliament Courts. The Corruption Investigations got Organised Crime Proof that was used for Office Unfitness Cases against Top Judges that got Protection Fraud Proof against Corrupt MPs. It got a Forced Resignation by Prime Minister Mrs May and the Forced General Election.
2. Citizens used Corruption Cases and Election Fairness Cases for Integrity Tests. They got Election Fraud Proof for the Citizen, Crown and Parliament against the Media, State, Law Courts and Top Politicians. They got it before and during the Election Campaign Period. It is Relevant Evidence for Parliament Session Decisions made by the Crown and Lord Bishops.
3. Citizen Mr Noakes has agreed use of his Extradition Fraud Appeal CO 4511 2019 in the Administrative Court and his Corruption Cases in the High Court Queen's Bench Division for Election Integrity Tests.
4. The 2010 Parliament Session Agreement contained Corruption Remedy Conditions. They required a Corruption Investigation of the Law Courts by the Lord Chancellor for the Crown. In late 2011 the Queen used a Firearms Corruption Proof Set + Protection Applications + a Secret Service Officer for an Integrity Test. The choice for the Sussex Police Chief Constable was a Corruption Investigation with Protection Justice for the Firearms Corruption Victim or a Protection Fraud for Corrupt Officers using Investigation Frauds and Prosecutions Frauds against the Victim. The Chief Constable chose Protection Frauds against the Victim. It got Firearms Crime Fraud Proof + Protection Fraud Proof for the Citizen Victim, Crown and Parliament against Witnesses + Investigators + Prosecutors + Trial Judges + Appeal Judges.
5. The Firearms Corruption Case created the Established Practice of the Sussex Crown Prosecutor acting as Receipt Agent + Receipt Proof Agent for Parliament Session File for the Director of Public Prosecutions. The Crown and Prime Minister use the same file. It eliminates Evidence Uncertainty. The Equity Lawyer walks away with Stamp Filing Proof on Multiple Originals or Copies for Verification Purposes and Further Investigation Purposes
6. Equity Lawyer Mr Ellis knew that a Planned Move of the Sussex Prosecutors' Office but not the Move Day. On Friday 29th November 2019 he visited with a Filing Set and discovered the move was in progress. The Crown Prosecutors considered the needed for a Security Vetting to give the Equity Lawyer access to the Crown Prosecutor Facilities for the Filing Process. He explained the need to make New Filing Arrangements might have Prejudicial Consequences for the Crown Prosecutors. They agreed he could visit again on Wednesday 4th December 2019.
7. Honourable Politician Mr Ian Duncan Smith will please give the Crown notice of the Filing Process Interruption. The Extradition Fraud CO 4511 2019 REVISED Appeal Grounds + Corruption Claim Form are Sample Evidence of the Filing Set.
