The circumstances

Citizen Mr Mustafa is a Corruption Victim. He has assisted Corruption Investigations. The Car Theft Allegation Fraud + Arrest Fraud + Mental Health Custody Fraud were Election Frauds. Citizen is using it for Corruption Investigations. The Citizen, Crown and Lord Bishops have Justice Responsibilities known as the Equity Monarchy Trusts. They have Corruption Control Jurisdictions that govern Parliament Session Powers. They fell into disuse for 45 years when the Politicians developed the European Constitution. It vested Dictator Powers in the State. Corrupt Officers and Law Court Judges formed Organised Crime Partnerships. They developed a Protection Fraud Network for Mutual Support and Corruption Co-ordination. Organised Crime got control of the State, Law Courts and Parliament

In 2002 a Drug Dealer was on Police Bail when she stole his car. She drove it around the Local London Borough for 6 weeks. It revealed she had Protection Frauds from Metropolitan Police Officers. Mr Mustafa saw her driving the car, called the police, kept the line open while he followed her and 12 minutes later witnessed the Car Theft Arrest. The Corrupt Officers who provided Protection Frauds for her needed Discredit Frauds against him. They used a Framing Fraud that got a 1st Offence Imprisonment Fraud and an Appeal Acquittal after completion of the Sentence Fraud. He did not know the Car Theft Arrest motivated the Framing Fraud. The Corrupt Officers rose up the ranks. He did not know they classified him as Corruption Exposure Risk to ensure that Any Problem got Repeat Framing Frauds.

The European Leaders wanted Referenda Acceptance of the Dictator Powers. They needed Election Frauds to get it. They managed it badly. In October 2004 the Fraud Proof was used to revive the Equity Monarchy Trusts. It started a Corruption remedy process that has continued ever since. In April 2017 it got Criminal Conspiracy Proof against Top State Officers and Law Court Judges. The Crown and Lord Bishops used it to decide the Corruption Remedy Conditions for the Parliament Session Agreement. They needed a Long Session of 2 ½ years to complete Corruption

Investigations of the Law Courts, get Corruption Cases against Top Judges and use them for Corruption Investigations in Parliament. Prime Minister Mrs May called a Surprise General Election to avoid a Parliament Session Refusal and Forced General Election with Mass Publicity for the Corruption Proof and Remedy Denial Fraud Proof. It got the Long Session and Corruption proof against Top Judges and Top Politicians

The 2017 General Election got a 48 Vote Majority for Nantwich and Crewe MP Ms Laura Smith.

In November 2017 Citizen Mr Mustafa was a Petrol Station Customer. He is Black. The Petrol Station Cashier gave Service Priority to White Customers against the Black Customer Mr Mustafa. He made a Racial Prejudice Complaint, The Cashier wanted to ignore it. The Citizen demanded the attention of the Petrol Station Manager and sight of the Video Record. The Petrol Station Manager was a White Woman. She threatened to call the police. The Citizen insisted the Police attend so that he could make a Racial Prejudice Complaint and they could seize the Video Record. Cheshire Police attended. It got a Racial Prejudice Bias Fraud + Arrest Fraud + Custody Fraud + Video Innocence Evidence Destruction Fraud by Cheshire Police for her against him. The Citizen had Jury Trial Rights and a Bias Fraud Defence. The choice for the Authorities was a State Case Withdrawal + Racial Prejudice Remedies for Citizen Mr Mustafa or Trial Fraud against him to get a Guilty Plea. They chose the Trial Frauds. The Citizen gave instructions for a Not Guilty Plea + Bias Fraud Defence. The Defender ignored the Defence Instructions. He made an Unauthorised Plea Bargain. . Citizen Mr Mustafa knew he had a problem. He discovered the Equity Monarchy Trusts of the Citizen, Crown and Lord Bishops. He discovered they were managing a Corruption Remedy Process using Case Management Services by Equity Lawyer Mr Ellis. He travelled from Crewe to London and asked the Equity Lawyer for help. The Corrupt Officers in the Metropolitan Police allocated a Surveillance Team to observe the London Trip. Citizen Mr Mustafa gave a Privilege Waiver and Confidentiality Waiver that enabled the Crown and Lord Bishops to use his case for Remedy Publicity. The Equity Lawyer helped him produce a Case Explanation Statement. In the early hours of 24th February 2018 Citizen Mr Mustafa signed the statement and left the Meeting House. The Surveillance Team stopped him and questioned him. Email Service of the Case Explanation Statement to the Government Lawyers on the Monday morning was followed on the Tuesday night with a Firearms Investigation Fraud + Mental Health Fraud + 8 Weeks Custody Fraud against the Citizen. He used all of it for Corruption Investigations for the Crown and Lord Bishops. It got Criminal Conspiracy Proof against the State Witnesses, Investigators, Prosecutors, Defenders, Magistrates Curt Judges and Crown Court Judges. It included Crown Court Audio Records of Trial Fraud Blackmail + Leniency Bribery by the Defenders, Prosecutors and Crown Court Judges that got a False Guilty Plea. In April 2019 he stood as an Independent Candidate for the East Cheshire Council Seat for Crewe Central Ward, conducted Election Research, got Campaign Management Sabotage Fraud Proof and 55 votes. The Equity Lawyer continued to service the Corruption Remedy Process. He sent Remedy Process Emails to All MPs. Citizens used their cases for Integrity Test before and during the Election Campaign Period. They got Corruption Proof, Remedy Denial Fraud Proof and Election Fraud Proof against the Media, State, Law Courts and Top Politicians. The Remedy Process Emails gave notice of the Test Results. Labour Supporters and MP Ms Smith thought Citizen Mr Mustafa planned to stand as an Independent Parliamentary Candidate. They used Election Sabotage Frauds to prevent him doing so. They started with Paedophile Defamation Frauds on the Facebook Account that is used by 20,000 Local Area Users. He travelled to London and completed High Court Papers for an Election Fairness Claim. They used His Car + Car Ownership Misrepresentation Frauds for a Car Theft Arrest Fraud + Mental Illness Case Reference Fraud + Mental Illness Custody Fraud against him. He had Hire Purchase + Motor Insurance Proof as Ownership Proof. The case is being used for a Corruption Investigation.
