1. The Parliamentary Constituency Election Fraud Cases against Citizens Mr Awodiya, Ms Berry, Mr Brooks, Mr Halil, Mr Mustafa, Mr O'Connor, Mr Say, Mr Taylor and Mr Yiannides

Sample Cases

- 1.1. The Brighton Kemptown Parliamentary Constituency Election Frauds against Citizen Mr Taylor:

- 1.1.1. The 2015 Parliamentary Candidacy got Election Campaign Sabotage Fraud Proof for Citizen Mr Taylor against Sussex Police and the Media

- 1.1.2. The 2019 Parliamentary Candidacy Announcement on 16th September 2019 got a Harassment Allegation Frauds + Arrest Fraud on 20th September 2019 + Investigation Frauds all of which were Election Campaign Sabotage Frauds Citizen Mr Taylor

- 1.2. The Nantwich and Crewe Parliament Constituency Election Frauds + Car Theft Framing Fraud + Mental Health Custody Fraud against Citizen Mr Adam Mustafa

- 1.2.1. The 2002 a Car Theft by a Drug Dealer discovered the Drug Dealer had Protection from Corrupt Police Officers. Citizen Mr Mustafa was the Theft Victim. They needed a Discredit Fraud against him. They got a Framing Fraud + 1st Offence Imprisonment Frauds against him. He got an Appeal Acquittal after completion of the Sentence Fraud. He did not connect the Car Theft and Framing Fraud. The Corrupt Officers rose up the ranks. He did not know that he would remain a Framing Fraud Target if anything else arose. 15 years later Race Bias Frauds by Cheshire Police for a White Petrol Station Cashier used an Investigation Fraud and an Investigation Denial Fraud for her against him. The choice for the Authorities was Race Bias Remedies for him or Trial Fraud Blackmail + Leniency Bribery to extort a Guilty Plea from him. They chose the Blackmail + Bribery. He used the case for Corruption Investigations that got Trial Audio Records that were Criminal Conspiracy Proof against the Witnesses, Investigators, Prosecutors, Defenders and Trial Judges. He stood as an Independent Candidate for the Council Elections and got Election Fraud Proof for Corruption Investigations. The Labour Party feared he would stand as a Parliamentary Candidate. They used a Facebook Account with 20,000 Local Users for Paedophile Defamation Frauds against him and Cheshire Police and His Car + Car Ownership Denial Frauds for a Car Theft Arrest Fraud + Mental health Case Reference Fraud + Custody Fraud + Forced Medication Frauds. All are Election Frauds

2. The Attempted Murder + Attempted Murder Protection Frauds

- 2.1. In 2000 Redbridge Council and Redbridge Magistrates Court serviced the Mercy Killing Murder of 5 Month's Old Miss Sunaina Chaudhari. Thereafter they managed Intimidation Frauds against Family Members. The Intimidation Frauds included Council Tax Liability Frauds against the Mother and Maternal Aunt. It got Target Status for the Council and Court in Corruption Investigations.

- 2.2. Prime Minister Mrs May issued a State Order for Hospital Murder. It needed Forged Blood Test Results to get a Kidney Failure Diagnosis + Dialysis Treatment Prescription + Treatment Consent and Hospital Death within an hour of the Consent Signatures. It failed. Killer Doctors were very enthusiastic. Decent Doctors gave Repeat Warnings that the Body Condition was inconsistent with the Blood Test Results. The Victim understood the Repeat Warnings, got criminal Conspiracy Proof against All Relevant Authorities, gave a Fistula Operation Preparation Consent, gained time for progress with the Dismissal

Case against Prime Minister Mrs May, received the Immediate Dialysis Treatment Notice and responded with a Treatment Refusal.

- 2.3. The Killer Doctors needed Protection Frauds from Prime Minister Mrs May. She dare not use a Mental Health Fraud for the Hospital Murder. It was obvious that the Killer Doctors would panic. They needed the Hospital Murder and would use a Mental Health Fraud to get it. The Victim used a Residential Tenancy and Housing Benefit Claim to get Benefit Denial Fraud Proof against Redbridge Council. Prime Minister Mrs May announced her Conservative Party Leadership Resignation. The Victim gave a Blood Sample. The Killer Doctors used Forged Blood Test Results for a Dialysis Treatment Offer with Mental Examination Condition Consent Condition. It got a Consent refusal by the Victim. The Killer Doctors and Redbridge Council used a Mental Health Arrest Fraud. It failed. The Secret Service knew where the Victim was but did not inform the Killer Doctors or Redbridge Council until it was too late.
3. The Harassment Framing Fraud against Citizen Mr Paterson.
 - 3.1. Top Police and Top Judges had an Illegal Drug Production Business in Sussex because the water is good for it. The Top Judges insisted Their Organised Crime Manager control the business because they did not trust anyone else to pay them. He needed Protection Frauds that would last his lifetime. He stole firearms and got Firearms Concealment Fraud Proof against Sussex Police. The Firearms Corruption Proof Set is the Convictions Record of the Organised Criminal, Receipt 0233607 that lists the Stolen Firearms and him as Possessor and Receipt 0223608 that lists the Cabinet from which they were stolen and stats 'locked – contents unknown'. Sin e January 2009 the Firearms Proof Set has been used thousands of times to discover who provides Protection Frauds for the Organised Criminal.
 - 3.2. The 2015 General Election got a Governing Majority for Prime Minster Mr Cameron. The Protection Fraud Network planned a Ruin Fraud to remove him from office. It needed Internet Publicity by an Innocent Agent, Censorship Motive Proof against the Prime Minister, a Framing Fraud against the Innocent Agent and exposure of it timed to do maximum damage to the Prime Minister. Everything that could go wrong for them did go wrong. Panama Papers Week prepared for a Framing Fraud Exposure Week that did not happen. Equity Lawyer Mr Ellis found the case. The Innocent Agent co-operated. They got Criminal Conspiracy Proof against Law Court Judges in time to stop Framing Fraud Exposure Week. Prime Minster Mr Cameron could do nothing about it at the time. The Brexit Referenda had priority. He led the Remain Campaign, lost and resigned. It was an Honourable Resignation.
 - 3.3. The Protection Fraud Network needed the Leadership Contest Winner to provide Protection Frauds for the Ruin Fraud Conspirators. Home Secretary Mrs May was the Top Ruin Fraud Manager. Money was no object buying Leadership Support for her. She got office as Prime Minister with Inconsistent Obligations. She had Witness Protection Justice Obligations to Citizens and Protection Fraud Obligations to Corrupt Officers, Corrupt Judges and the Protection Fraud Network. The Equity Lawyer and Innocent Agent made immunity Negotiation Offers. The Police Officer Witnesses wanted Immunity Deals in exchange for Full Disclosure about the Framing Fraud Orders. The Protection Fraud Network needed Intimidation Frauds to get Repeat Perjury from the Police Officers, Repeat Misrepresentation Frauds from the Crown Prosecutors and Repeat Trial Frauds from the Junior Appeal Judges at the Framing Fraud Appeal.Rights Reserved for Further Details.....
