Conflict Disqualification Finding + Remedy Only Jurisdiction Limit Finding + Case Reference to the High Court Order + Joint Case Management with Contempt Claim Fraud QB 2020 000968 Order for the Citizen Beneficiary Mr Sham Sood against his son, Trustee Mr Sood for the Stated Reasons that:


1. The Corruption Remedy Conditions in the Parliament Session Agreement required a Royal Commission to manage Corruption Remedies for Victims before the Session End with a Default Penalty of a Parliament Session Refusal and Forced General Election with Mass Publicity for the Corruption Proof and Remedy Demnial Fraud Proof.

2. Citizens used their cases for Integrity Tests that did not get Corruption Remedies but got Remedy Denial Fraud Proof that can be used for Partliament Session Decisions.

3. Claim Frauds by the Trustee and the Trust Breach Claims by the Beneficiary got Criminal Conspiracy Proof the Citizen Beneficiary against the Trustee, His Representatives the Beneficiary Representatives and County Court Judges. The Contempt Fraud Claim QB 2020 000968 got Remedy Denial Fraud Proof + ProtectionFraud Proof for the Citizen Beneficiary against High Court Justice Mrs Eady. He used it for the Fraud Appeal to the Court of Appeal. It got Pending Adjudication Protection Rights for the Citizen Beneficiary against the Inferior Law Courts including the High Court. Justice requires the Remedy Orders
