

Royal Commission + QB2019 003984 Interim Remedy DRAFT Order

Before High Court Justice on May 2020

Upon the Citizen Claimant acting In Person and having Turkish Literacy and English Illiteracy and Limited Case Management Capacity that creates a Legal Assistance Obligation for him against the Government Lawyers

Upon the Citizen Claimant having made a Shop Theft Crime Complaint that got Investigation Denial Fraud Proof against the Metropolitan Police

Upon the Citizen Claimant having Pending Adjudication Protection Rights from the High Court and Court of Appeal against the State got by issue of Shop Theft Claim QB 2019 003741 and Corruption Claim QB 2019 003984 in the High Court and Witness Status in Contempt Claim QB 2020 000286 in the High Court and Witness Status in Fraud Appeal 2020 0396 in the Court of Appeal

Upon the Citizen Claimant having made Damage Mitigation Applications in Claims QB 2019 003741 and QB 2019 003984 that got Hearing Denial Fraud Proof against the High Court and the 1st Backdated Order Forgery with Alleged Date 31st October 2019 by the High Court

Upon the Damage Mitigation Applications having motivated a 1st Protection Fraud Call for an Investigation Fraud and Finding Fraud by the Metropolitan Police that Top Judges could use for a Claim Dismissal Fraud

Upon the Protection Fraud Call having got a Complainant Interview that the Citizen Claimant used to present Criminal Conspiracy Proof that included the 1st Backdated Forgery that got Investigation Denial Frauds and Finding Fraud Failure by the Metropolitan Police

Upon the Finding Fraud Failure motivating a 2nd Backdated Order Forgery with Alleged Date 12th November 2019 by the High Court

Upon the Citizen Claimant having Damage Mitigation Obligation that he managed by use of a Restocking Event on 25th March 2020 for Physical Repossession that got an Eviction Fraud for the Organised Crime Buyers against Citizen Mr Yediayli by the Metropolitan Police

Upon the having used the Eviction Fraud for an Interim Remedy Application that did not get Physical Filing on 26th March 2020 because of the Corona Virus Emergency Court Closure but did get Email Filing and Email Service

Upon the Interim Remedy Application getting the response of a Judgment + Restraint Application of the Organised Crime Buyers that disclosed a 3rd Backdated Order Forgery by the High Court with the Alleged Date 17th January 2020

Upon 3rd Backdated Order Forgery Requests for Citizen Mr Yediayli getting Order Supply Refusals by the Organised Crime Buyers and the High Court

Upon the Caution Appointment Notice for 9 a.m. on 2nd June 2020 at Bethnal Green Police Station being Protection Breach Contempt Fraud Proof for the Citizen Claimant against Metropolitan Police and the Ministry of Justice
