Appeal + Claim Notice against the Employment Termination dated 18th May 2020 in the circumstances:

- 1. The Employer appointed the Citizen as an Accounting Clerk
- 2. The Employment Legislation and Corona Virus Emergency imposed Safety Conditions
- 3. The Citizen made Safety Condition Compliance Demands that got the Immediate Response of a Dismissal Fraud using a Redundancy Reason Fraud by the Employer. The Immediate Dismissal was a Compliance Avoidance Fraud + Employment Termination Fraud with the Fraud Proof including Internet Advertising for an Accounting Clerk
- 4. Fraud Proof invalidates Liability Limitations and gets Personal Liability for the Responsible Officers
- 5. The Glorious Revolution of 1689 define Justice Responsibilities known as the Equity Monarchy Trusts for the Citizen, Crown and Lord Bishops and vested in them Corruption Control Jurisdictions that govern Parliament Session Powers.
- 6. The European Constitution vested Dictator Powers in the State. The Politicians lost control to Corrupt State Officers and Law Court Judges who formed Organised Crime Partnerships. They developed a Protection Fraud Network to provide Support Services and Corruption Coordination.
- 7. In 2004 the European Leaders wanted Referenda Acceptance of the Dictator Powers. They needed Election Frauds to get it. Everything that could go wrong for them did go wrong. They used Extradition Frauds and Imprisonment Frauds to prevent exposure of the Election Frauds. The Election Fraud Proof was used to revive the Equity Monarchy Trusts and start a Corruption Remedy Process that has continued ever since. It needed to achieve Total Destruction of the Protection Fraud Network.
- 8. The Protection Fraud Network sold Drug Research Testing Frauds to the Pharmaceutical Industry and used State Schools to identify Target Children for Secret Forced Mediation Frauds. In 2015 Citizens Mr and Mrs Awodiya found out, asked questions and became Ruin Fraud Targets. They used Fraud Claims to get Criminal Conspiracy Proof against the Law Courts and gave it to the Crown and Lord Bishops. In 2019 they used it to get a Forced Resignation by Prime Minister Mrs May and a Forced General Election. Citizens managed Integrity Tests before and during the Election Campaign Period against All Party Leaders. The Crown and Lord Bishops imposed Remedy Conditions in the Parliament Session Agreement that a Royal Commission manage Corruption Remedies for Victims before the Session End. The Default Penalty is a Parliament Session refusal and Forced General Election with Mass Publicity for the Corruption Proof, Remedy Denial Fraud Proof and Election Fraud Proof. Integrity Tests included a Council House Purchase Application by the Citizen. It got Process denial fraud Proof from Leeds City Council and an Employment Termination Fraud by the Employer who do Council Business. It is Contempt Fraud Proof for the Citizen and Remedy Process subject to Rebuttal Proof from the Employer
