 - 1.1. The Testatrix had a number of Children and Grand Children.
 - 1.2. The Testatrix made a Will in 1987 that made a Gift to One Daughter without a Substitution Gift in favour of the Daughter's Heirs, and an Executor Appointment of Equity Lawyer Mr Ellis
 - 1.3. The Testatrix made a Lifetime Gift to the Daughter of 99% of a Property and retained 1%.
 - 1.4. The Testatrix signed a Statement that revealed she made a Will in 2007 but did not explain more.
 - 1.5. The Daughter died and her Daughter obtained a Probate Grant to the Daughter's Probate Estate
 - 1.6. The Testatrix died leaving a Small Estate that included the 1% interest in the Property
 - 1.7. The circumstances needed Equitable Due Process of a Current Valid Will Investigation and examination of the 2007 Will to discover whether it contained a Pervious Will Revocation that deprived the 1987 of Current Will Status, and in any event, whether Will Trusts or Intestacy Trusts governed Estate Benefits.
 - 1.8. A Son of the Testatrix moved into the Property an Intestacy Trust Probate Grant of the Probate Estate
 - 1.9. In 2017 the Claimant and Claim Lawyers:
 - 1.9.1. disclosed the death of the Testatrix,
 - 1.9.2. pretended the 1987 Will had Current Valid Will Status,
 - 1.9.3. denied disclosure of the existence and content of the 2007 Will,
 - 1.9.4. denied disclosure that the 1987 Will created Lapsed Gift created Intestacy Trusts
 - 1.9.5. denied disclosure of the identity of the Intestacy Beneficiaries
 - 1.10. It got an Unconditional Renunciation by Mrs Jessup and a Renunciation Offer by the Equity Lawyer subject to Due Process Conditions that required Informed Consent by All Interested Parties and disclosed the Corruption Remedy Process managed by the Citizen, Crown and Lord Bishops
 - 1.11. It got a Due Process Conditions Rejection and Repeat Unconditional Renunciation Demands
 - 1.12. The Claimant made a Grant Revocation Claim in the Family Court against the Maternal Uncle and an Executorship Renunciation Claim in the Chancery Court against the Equity Lawyer.
