The Remedy Process needs the Chronology. It is not complete. It is the best the Equity Lawyer can do in the circumstances.

In 2004 European Leaders committed Referenda Frauds and needed Concealment Frauds. They used Extradition Frauds and Imprisonment Frauds against a British Citizen. Equity Lawyer Mr Ellis used the Fraud Proof to revive the Equity Monarchy Trusts, that had been dormant for 45 years, and get the Corruption Remedy Process. It needed to achieve Total Destruction of the Protection Fraud Network. The Network provided Support Services and Corruption Coordination for Organised Crime Partnerships managed by State Officers and Law Court Judges. They committed Remedy Sabotage Frauds at every stage of the Remedy Process. In 2018 and 2019 they used Kidney Failure for Treatment Denial Frauds with intent to get a Hospital Murder of the Equity Lawyer. They did not get it. In 2019 they needed a Middle Eastern War. They did not get it. Then they needed Extradition Fraud Blackmail of the Crown. They prepared for it.

In April 2020 End Stage Kidney Failure got an Emergency Hospital Admission for the Equity Lawyer. The Protection Fraud Network used it to plan a Kidney Failure Dialysis Treatment Sabotage Fraud using a Urea Poison Fraud. It failed. It increased the need for the Extradition Fraud Blackmail against the Crown. The Remedy Process needed Proportionality Evidence the Lord Bishops could use for Remedy Publicity and resist the Extradition Fraud Blackmail.

The Chronology serves that purpose. It is the best the Equity Lawyer can do with Unreliable Computers when recovering from the Body Damage done by End Stage Kidney Failure and servicing the Integrity Test Cases. The Body Damage Repairs were in two stages. The body did Low Quality Emergency Healing that resulted in Solid Lumps in the flesh. The Equity Lawyer made Fitness Efforts. The body responded with Healing Improvements that gradually eroded the Solid Lumps and got Partial Recovery. The body needed Extra Sleep to manage the Healing Improvements. When the Equity Lawyer gave Immediate Attention to the Remedy Process the Healing Improvements stopped. It was as if the Priority Management passed between the Conscious and Subconscious. The Corona Virus Emergency caused Treatment Delays and Fibrosis Healing Problems. 	The Remedy Process used Integrity Test Cases to identify the Top Level Corruption Controllers.
