Remedy Process Notice + Integrity Test Notice:

1. The Remedy Process needed Corruption Proof for Unfitness Cases against Top Judges in Parliament. Honourable Parliamentarians needed the Corruption Proof to silence Corrupt Parliamentarians who provided Protection Frauds for Corrupt Top Judges.
2. Citizens used their cases for Integrity Tests that forced Organised Criminals and Corrupt Officers to demand Protection Frauds by Top Judges. They got Criminal Conspiracy Proof against All Guilty Parties and Corruption Controller Proof against Top Judges.
3. The Corruption Controller Proof against Top Judges includes the use of Appeal Regulations and Case Officers and Case Masters in the Court of Appeal for Evidence Exclusion Frauds and Regulation Compliance Failure Dismissal Frauds.
4. Corrupt Officers managed Protection Frauds for Powerful Paedophiles and then demanded Protection Frauds for themselves. They needed use of Contempt Claim Fraud 2019 004208 for Trial Frauds against Citizen Ms Berry by Top Judges.
5. Fraud Appeals 2020 0395 + 0396 were used for the Conflict Qualification Fraud Proof Test. It used a Common Bundle for both cases that contained the Fraud Proof against Top Judges.
6. Fraud Appeal 2020 0396 was used for a Formal Warning that the use of the Core Bundle Regulation to get Conflict Qualification Fraud Proof Exclusion Frauds for Corrupt Top Judges against the Citizen would get Corruption Controller Liability and Penalty Findings against the Case Officer and Case Master.
7. Fraud Appeal 2020 0395 was used for a Remedy Application. On the evidence available the Corruption Controller Liability Warning got a Fraud Remedy Application Reference to the Master of the Rolls and an Application Dismissal Fraud dated 17th July 2020 by Lord Justice Lewison. On 23rd July 2020 Citizen Ms Berry used the Dismissal Fraud for a Fraud Appeal to the Supreme Court and then appeared at the 2019 004208 Trial Event. It got an Audio Record that is Criminal Conspiracy Proof against State Lawyers, State Counsel and the Trial Judges. It includes a Pending Appeal Protection Rights Admission by the Trial Judges and Protection Breach Contempt Fraud Proof against the State Lawyers, State Counsel and the Trial Judges.
8. The Remedy Process needed Case Filing Comparison Tests using the Fraud Appeal Electronic Filing in the Supreme Court and the Royal Mail Signed For Post Filing in the Royal Courts Post Room of the Corruption Claim of Citizen Tenant Mr Hasrtunc in the High Court and the Fraud Appeal 2020 PI 10942 Fee Remission Application Filing in the Court of Appeal
9. On 24th July 2020 the Fraud Appeal 2020 PI 10942 Fee Remission Deficit Notice Email at 09.13 from the Court of Appeal was followed by a Signed For Post Room Receipt at 10.51.
