Protection Breach Contempt Trial Fraud Appeal against the High Court Contempt Claim Fraud 2019 004208 dated 21st July 2020 of High Court Justice Mr William Davis and Lord Justice Mr Singh

Applications: Appeal Regulation Waivers + Public Expense Entire Process Transcript + High Court Records Production + Fraud Case Reference by the Case Officer and Case Master to the Master of the Rolls

Grounds: Fraudulent Breach of Natural Justice + Human Rights + Overriding Justice Objective

1. Criminal Conspiracy on Unknown Dates by the State Counsel Mr Eardley, State Lawyer Ms Kenlock, the High Court Justices, High Court Supervising Lord Justices, Court of Appeal Lord Justices and the Master of the Rolls to commit Trial Frauds against the Citizen that required:
 - 1.1. Protection Breach Contempt of the Pending Adjudication Trial Stay Protection got by the Committal Application Permission Fraud Appeal 2020 0395 in the Court of Appeal
 - 1.2. Bias Frauds for the Solicitor General against the Citizen at every stage of the process using Legislation Frauds, Regulation Frauds, Policy Frauds and Practice Frauds
 - 1.3. Trial Listing Fraud on an Unknown Date by the High Court Lord Justices
 - 1.4. Committal Application Permission Fraud Appeal 2020 0395 Conflict Qualification Fraud + Permission Refusal Fraud dated 17th July 2020 by Lord Justice Mr Lewison

 - 2.4. Ignoring the Appeal Period Protection Rights from the Supreme Court and

3. Trial Continuity Fraud on 21st July 2020 in Royal Court 16 by High Court Justice Mr Davis and Lord Justice Mr Singh that got an Audio Record that evidenced:
 - 3.1. Oral Notice by Equity Lawyer Mr Ellis that Citizen Ms Berry had filed a Fraud Appeal in the Supreme Court and was late because she was collecting prints of the Appeal Papers
 - 3.2. Short Adjournment by the Trial Judges
 - 3.3. Citizen arrived with the Appeal Papers and had to separate them for service
 - 3.4. Appeal Papers Service by the Equity Lawyer on the Judges Clerk and State Counsel
 - 3.5. Return + Resumed Sitting by the Trial Judges
 - 3.6. Hearing Priority Fraud for the Committal Application of the Solicitor General against the Before Trial Remedy Application of the Citizen
 - 3.7. Before Trial Remedy Application Hearing Priority Demand by the Citizen
 - 3.8. Before Trial Remedy Application Hearing by the Trial Judges
 - 3.9. Remedy Application Assistance Refusal Fraud + Harassment Frauds by the Trial Judges

Stated Reasons

The Citizen, Crown and Lord Bishops have Justice Responsibilities known as the Equity Monarchy Trusts. They have Corruption Control Jurisdictions that govern Parliament Session Powers. They have used them for a Corruption Remedy Process. The Corruption Remedy Conditions in the Parliament Session Agreement made in December 2019 between the Crown and Prime Minister required Corruption Remedies before the Session End. The Default Penalty is a Parliament Session Refusal and Forced General Election with Mass Publicity for the Corruption Proof, Remedy Denial Fraud Proof and Election Fraud Proof. Honourable Parliamentarians needed Proof Sets that silenced Corrupt Parliamentarians. It needed Criminal Conspiracy Proof against Justices of the High Court and Lord Justices of the Court of Appeal.

Citizens used their cases for Integrity Tests that forced Corrupt Officers to demand Protection Frauds from Law Court Judges. They got Criminal Conspiracy Proof. It included Family Sabotage Frauds + Crime Framing Frauds + Liability Imposition Frauds + Asset Thefts against Citizens and Protection Frauds for Organised Criminals.

Corrupt Officers managed Investigation Denial Frauds for Powerful Paedophiles in the Hampstead Case. The Remedy Process motivated the Corrupt Officers to demand Protection Frauds. They were given Harassment Trial Frauds against Mrs McNeil. They used them for Contempt Prosecution Frauds against Victims in the Crown Court and the Contempt Claim Fraud 2019 004208 against Citizen Ms Berry in the High Court.

Citizen Ms Berry used the Defence Case for Integrity Tests. They got Criminal Conspiracy Proof against the State Counsel, State Lawyers, High Court Judges and Court of Appeal Judges. They committed the 2019 004208 Trial Listing Fraud. It was a Pending Adjudication Trial Stay Protection Breach Contempt Fraud against the Court of Appeal. Then they committed a Fraud Appeal 2020 0395 Before Trial Remedy Application Dismissal Fraud and used it as an Appeal Dismissal Fraud to continue the Trial Fraud. It was an Appeal Period Protection Breach Contempt Fraud against the Supreme Court. They committed a Before Trial Remedy Application Hearing Denial Fraud and Trial Start Fraud. They committed a Trial Continuity Fraud that was a Pending Appeal Adjudication Trial Stay Protection Breach Contempt Fraud. The Trial Frauds were: Before Trial Remedy Application Hearing Denial Frauds and Dismissal Frauds + Trial Adjournment pending Appeal Adjudication by the Court of Appeal but not the Supreme Court + Recusal Refusal Fraud and Case Reservation Fraud + Trial Directions Frauds + Reserved Costs Fraud on 21st July 2020. The Fraud Appeal 2020 0395 Dismissal Clarification Request Email at 14.21 on 22nd July 2020 from the State Lawyer to the Court of Appeal exploits the Adjournment Reason Fraud that ignores the Supreme Court Appeal and is a Protection Breach Contempt Fraud against the Supreme Court. The Trial Fraud Appeal forces the Court of Appeal to process the Appeal 2020 0395 Fraud Proof against the Lord Justice Lewison and the Court of Appeal. It creates a Conflict Jurisdiction Disqualification and a Remedy Only Jurisdiction Limit for the Citizen against the State and the Court of Appeal. All of it is Criminal Conspiracy Proof for Corruption Unfitness Cases against Top Judges in Parliament and Contempt Fraud Cases in the Law Courts.
