 - 8.1. The Criminal Conspiracy Proof needed to include Hearing Avoidance Frauds and Unavoidable Hearing Management Frauds. The Sentence Breach Framing Fraud 0120002666764 in the Magistrates Court, Divorce Case ZC14D02308 Fraud Revocation Application in the Family Court and Violent Harassment Restraint Protection Denial Fraud Appeal in the Court of Appeal provided Unavoidable Hearings.
 - 8.2. Divorce Case ZC14D02308 Fraud Revocation Application Hearing on 20th January 2020, Audio Record, and Adjourned Hearing Date Order for 25th August 2020 are Remedy Denial Fraud Proof + Criminal Conspiracy Proof for Citizen Mrs Theodorou against Respondent Mr Theodorou, the Respondent's Representatives and District Judge Stone. It made Land Frauds in North East London an Obvious Choice to get Similar Fact Crime Conspiracy Proof for Honourable Parliamentarians, Lord Bishops and Crown.
 - 8.3. The Sentence Breach Framing Fraud 0120002666764 enabled Citizen Mr Nkrumah to present Prison Release Licence Forgery Proof against the State at the Plea Hearing on 19th February 2020. It got Attempted Remedy Co-operation by the Court Lawyer and Remedy Hearing Denial Fraud Proof + Trial Fraud Proof against the Magistrates Chairman. Fraud Managers had an Unavoidable Hearing and used Repeat Adjournment Frauds and Attendance Prohibitions against both the Citizen and the State.
 - 8.4. Land Fraud Cases in North East London got Criminal Conspiracy Proof against Top Judges. They used Hearing Denial Frauds and Adjournment Frauds to avoid Audio Records of Criminal Conspiracy Proof.

- 8.5. The Court of Appeal Fraud Appeal 2019 1483 Permission Hearing on 29th July 2020 used Royal Court 71 Allocation Proof against the Master of the Rolls and got an Audio Record that was Criminal Conspiracy Proof against Organised Criminal Mr Seton and Appeal Lord Justices.
- 8.6. The Divorce ZC14D02308 Fraud Revocation Representations dated 6th August 2020 of the Citizen were filed with the Family Court and served on the Respondent with the Royal Commission Email dated 11th August 2020 by Equity Lawyer Mr Ellis. It forced Hearing Management Communications between the Fraud Managers. The Respondent's Case Manager had Secret Communications with the Family Court on Saturday and Sunday 22nd and 23rd August 2020. The Hearing Management Communications on 24th August 2020 were:
- 8.6.1. Court Communication Agency Claims + Skype Hearing Instruction by the Respondent's Case Manager
- 8.6.2. Communication Agency Rejection + Direct Communications Demand + Skype Hearing Objection + Court Room Hearing Demand by the Citizen
- 8.6.3. Telephone Hearing Instructions by the Respondent's Case Manager to the Citizen
- 8.6.4. A Court Room Hearing Application + Proposals + Representations by the Citizen Applicant and Email Service by Equity Lawyer Mr Ellis
- 8.6.5. The Hearing Management Email at 16.10 from the Respondent's Representative to the Citizen purports to quote a Directions Hearing Decision + Reasons by District Judge Stone
- 8.6.6. The 1st Hearing Management Email at 16.21 from the Family Court Listing Officer to the Citizen did not provide that Hearing Management Details provided by the Respondent's Representative 11 minutes earlier
- 8.7. The Hearing Event got an Unexplained 1 Hour Delay + Electronic Records that are Criminal Conspiracy Proof for the Citizen Mrs Theodorou, Honourable Parliamentarians, Lord Bishops and Crown against Respondent Mr Theodorou, Respondent's Representatives and District Judge Stone. It includes the Recusal Failure Fraud + Conflict Qualification Fraud + Remedy Only Jurisdiction Limit Fraud + Jurisdiction Issue Exclusion Frauds + Issue Restriction Fraud + Evidence Exclusion Fraud + Applicant Representations and Bundle Service and Filing Denial Frauds + Respondent's Representations and Bundle Service and Filing Order Compliance Failure Immunity Fraud
- 8.8. The Directions Orders included a Court Room Representations Filing Order + 2 Day Filing Time Limit.
- 8.9. On 26th August 2020 the Framing Fraud 012000266764 got Hearing Bias Fraud Proof for the Citizen Mr Nkrumah against the State and Magistrates Court. The Morning List had 10 cases and the Case Reference for his case omitted the first two numbers. The Citizen was the only Case Defendant who appeared for the Morning List

8.9.1. The Bias Frauds started with a Court Room Access Denial Fraud against the Citizen before the State Prosecutor arrived, and then Court Room Access for the State Prosecutor and Access Denial Fraud by the Court Usher against the Citizen and then a Case Call by the Usher that got Court Room Access for the Citizen

8.9.2. The Bias Frauds continued with a Conflicted Interest Recusal Failure Fraud by Magistrates Chairman Mr Smalling. Then it continued No Jurisdiction Plea Denial Fraud + Jurisdiction Trial Denial by the Prosecutor, Court Lawyer and Magistrates using a Repeat Plea Hearing Fraud. It got Repeat Plea Hearing Fraud Objections by the Citizen who insisted on a Fraud Case Dismissal + Contempt Fraud Remedy Application. It got Liability Enquiries by the Court Lawyer and a Liability Enquiry Engagement Refusal by the Citizen who gave the Stated Reason that the Liability Enquiry was a Repeat Plea Hearing. The Citizen began the Case Dismissal + Contempt Remedy Application. Magistrates Chairman Mr Smalling and the Other Magistrate got up and walked out. The Court Lawyer made a Priority Decision for the Citizen's Case against the State Case and recalled the Magistrates to pronounce the Application Hearing Order for 10 September 2020.

8.10. On 27th August 2020 there was Email Filing in the Family Court of the ZC14D02308 Court Room Hearing Representations by Citizen Mrs Theodorou and Physical Filing in the Magistrates Court and Receipt Stamp Proof got on the Sentence Breach Framing Fraud Contempt Remedy Application Grounds of Citizen Mr Nkrumah. It was obvious the Case Management was designed to service Fraud Appeals to the Crown Court and Court of Appeal.

8.11. On 9th September 2020 the Royal Commission Email attached the Criminal Witness Statement of the Equity Lawyer and effected Email Filing of it in the Law Courts

8.12. On 10th September 2020 Citizen Mr Nkrumah got Repeat Stamp Filing Proof on the Contempt Remedy Application Grounds and forwarded the Royal Commission Email to the Magistrates Court who produced prints of it and the attachments and gave them to him. Investigation is needed to discover who made the Case Management Decisions for a State Case Withdrawal and Withdrawal Notice to the Magistrates Court and Notice Denial Fraud against Citizen Mr Nkrumah. Sentence Breach List Judge received the State Case Withdrawal Notice, and started Ritual Humiliation Frauds with Case Withdrawal Non-Disclosure Fraud + Case Call Delay Frauds that were False Imprisonment Frauds False Imprisonment Frauds. The Ritual Humiliation Frauds continued with a Case Call + Representation Facility Equality Denial Frauds + Dock Entry Demand + Legal Assistant Access Denial Fraud. The Dock Entry Refusal + Facilities Equality Demand + Legal Assistant Access Demand got a Pending Dock Entry Adjournment Fraud by the Trial Judge, Intimidation Frauds by the Court Clerk, a Case Management Conference by the

Citizen, Legal Assistant and Public Gallery Witnesses one of whom was the Equity Lawyer and Conference Sabotage Frauds by the Usher and Court Clerk. One Sabotage Fraud was an Attempted Eviction Fraud against a Public Gallery Witness for holding his Mobile Phone. He said he used it for Event Time Checks for the Hearing Report. The Court Officer insisted Time Checks be outside the court room. The Legal Assistant said the judge was not present. It broke the confidence of the Court Officer to continue with the Eviction Fraud. The Dock Entry by the Citizen was Without Prejudice to Invalidity Arguments. It got a Resumed Hearing, Video Link Appearance by the State Prosecutor, a State Case Withdrawal Application, Public Interest Reason + Expired Sentence Period Reason + No Mention of the Licence Release Forgery. It got a Costs + Contempt Remedy Application by the Citizen and an Application Notice Denial Fraud + Application Notice Filing Demand + Hearing Denial Fraud by the Trial Judge. Citizen Mr Nkrumah, Equity Lawyer Mr Ellis and Citizen Ms Tucker went to an Interview Space for a Hearing Denial Fraud Appeal Conference. It is not an Interview Room. The walls do not reach the ceiling. The sounds ricochet off the walls and ceiling and can be heard in Adjoining Interview Spaces. Citizen Mr Nkrumah produced the Case Papers from a Big Bag. The Equity Lawyer explained that Best Case Management for the Crown and Lord Bishops needed Case Chronologies and a Consolidated Chronology. He explained how to do it. Within a few minutes Eavesdroppers knew Citizen Mr Nkrumah had the Case Papers and a Reasonable Belief but False Belief that a Papers Loss would be a Catastrophic Loss. The Equity Lawyer left. A Young Man approached him and asked what he did. It was obvious he had been listening. The Equity Lawyer gave a Brief Explanation of the Equity Monarchy Trusts, went back to the Interview Space, got the Application Notice dated 27th August 2020 that bore a Receipt Stamp and used it to demonstrate how the Citizen met the Corruption Remedy Proof Standard. A woman appeared and told the Equity Lawyer she had Representative Status for the Young Man. He told her they were talking about something else. She called him away and walked towards Court 1. The Young Man asked for contact details. The Equity Lawyer gave his Mobile Phone Number. The Young Man gave his name as he walked away but the Equity Lawyer did not hear it. Citizen Mr Nkrumah appeared. The Equity Lawyer asked him to check whose case was in Court 1. He did and said it was closed. The Equity Lawyer left. Citizen Mr Nkrumah helped Citizen Ms Tucker with Case Preparation until Court Building Closing Time. There was a Big Bag Snatch + Case Papers Theft by Anonymous Thieves from Citizen Mr Nkrumah by a Railway Station. It was not a Catastrophic Loss for the Citizen, Parliament and Crown. The Filed Documents were Official Records that enabled Evidence Production Orders by the Lord Bishops for the Citizen against the State. The Big Bag + Case Papers Theft Complaint 2822049 2020 got an Immediate Investigation Denial Fraud + Immediate Case Closure Fraud by the Metropolitan Police. It added to the Criminal

8.13.
