Grounds: Fraudulent Breaches of Natural Justice + Human Rights + Overriding Justice Objective

Top Judges sold Land Frauds for Organised Criminals against the Citizen and the State. He agreed use of the cases for a Corruption Investigation. Top Judges sold Land Frauds for the Family Trustee Son against the Trust Beneficiary Father. The Trust Claim B01B00837 and Corruption Claim 2020 000968 and Fraud Appeal 2020 0742 got Criminal Conspiracy Proof against the County Court, High Court and Court of Appeal. The Corruption Claim and Fraud Appeal vested Conflict Jurisdiction in Superior Courts and created Pending Adjudication Enforcement Stay Protection Rights and Pending Adjudication Remedy Only Jurisdiction Limit for Citizen Mr Sood against Trustee Mr Sood, Lawyers, a Bank and the County Court. The Remedy Dismissal Decision was a Protection Breach Contempt Fraud against the Superior Courts. The Hearing Judge used an Evidence Exclusion Frauds against the Draft Remedy Order dated 16<sup>th</sup> October 2020 and the Trial Readiness Enquiry Response dated 23<sup>rd</sup> October 2020 both of which are repeated below.

#### Stated Reasons

In 1953 the Citizen Father was born into a poor Indian family. He had very limited education. In 1976 he spoke no English when he came to England for an Arranged Marriage. He is a Successful Immigrant. He learnt basic English, had a successful working life and a successful marriage with four children. Medical Negligence caused the death of his wife. He used Medical Negligence Damages to provide capital that enabled his sons to raise Buy to Let Mortgages and buy properties on trust for him. He used one property to house them and the rental income to finance their educations. All four children have professional qualifications. In 2013 the Trustee Son signed a Trust Declaration for the Citizen Father. In 2014 the Trustee Son committed Trust Frauds against the Citizen Father. The court has no need to detail the Trust Frauds because the Claim Fraud B01B0837 got Sale Orders and Sale Order Breach Contempt Fraud Proof against

Mortgages and made Purchase Offers that got Sale Refusal Fraud Proof + Order Breach Contempt Fraud  
Proof + Contempt Immunity Fraud Proof that were Criminal Conspiracy Proof against the Trustee Son, Case  
Lawyers and County Court and Contempt Remedy Denial Fraud Proof against the High Court and Court of  
Appeal. Fraud Proof on anything gets a Proof Burden Reversal for the Victim against the Guilty Parties. The  
Citizen Father gave a Privilege Waiver and Confidentiality Waiver that enabled the Crown and Lord Bishops  
to use the case for Parliament Session Decisions and Remedy Publicity. The Corruption Claim and Fraud  
Appeal got Without Hearing Case Dismissal Fraud Proof against the High Court and Court of Appeal. The  
Case Dismissal Hearing Demands enable Superior Jurisdiction Protection Enforcement Tests of the County  
Court at the Remedy Application Hearing listed for 23<sup>rd</sup> October 2020
