against the Inland Revenue for the Stated Reason that
 - 3.1. The Parliament Session Jurisdiction of the Citizen, Crown and Lord Bishops use the Common
Law.
It uses an Evidence Balance with Presumptions that are subject to Rebuttal Proof. The Start
Balance is a Validity Presumption for the Defender subject to Rebuttal Proof from the
Prosecutor. Fraud Proof of anything gets a Proof Burden Reversal for the Victim against Fraud
Managers and Fraud Beneficiaries that is subject to Rebuttal Proof
 - 3.2. The Protection Fraud Network sold Land Frauds for Organised Criminals against Victims that
needed Fraud Executions by Law Court Judges. They used Financial Service Agents as Scouts
to identify Fraud Targets.
 - 3.3. The Father, Mr Sham Sood spoke no English in 1976 when he came to England for an
Arranged Marriage. He made a success of the marriage and his working life. He had Limited
Language and Limited Literacy. He provided Equity Capital that enabled the two older sons to
raise Buy to Let Mortgages as Buying Agents and Sole Trustee for the Father. It enabled the
Father to house the family and give all 4 children financial support until they had University
Degrees and Profession Qualifications.
 - 3.4. The 2nd Son, Mr Vishal Sood, is in Financial Services. He signed a Trust Declaration that
acknowledged the Beneficiary Status of his Father. Later he committed Trust Breaches by use
of assets for Personal Benefit and Accounting Failures and issued Trust Claim B01B0837. Trial
Fraud Blackmail got the Agreed Directions that included the Sale Orders. The Agreed
Directions are Ruin Fraud Proof for the Father against Trustee Son, Lawyers and County Court
Judges. There is Low Stamp Duty for Trustee Transfers and High Stamp Duty for Sale
Transfers. The use of Sale Orders instead of Trustee Title Transfer Orders is Malicious Damage
Proof.

- 3.5. The Youngest Son, Mr Aman Sood, got Mortgage Offers and made two Purchase Offers as Buying Agent for the Father. The Purchase Offers got Sale Refusals by the Trustee Son and Mortgage Cost Losses for the Youngest Son and Father. A Hearing Audio Record is part of the Sale Refusal Proof. It is Sale Order Breach Contempt Fraud Proof against the Trustee Son and Contempt Immunity Fraud Proof against County Court Judges. It added to the Malicious Damage Proof. It got a Proof Burden Reversal for the Father and Youngest Sons against the Trustee Son and the County Court.
- 3.6. It made Trust Claim B01B0837 an excellent case for Corruption Investigations of the Law Courts.
- 3.7. The Citizen Crown and Lord Bishops have Justice Responsibilities known as the Equity Monarchy Trusts. They have Corruption Control Jurisdictions that govern Parliament Session Powers. They used them for a Corruption Remedy Process. In December 2019 the Parliament Session Agreement required that a Royal Commission get Corruption Remedies before the Session End. On 19th December the Queen announced it in the Parliament Session Opening Speech. Honourable Parliamentarians needed Criminal Conspiracy Proof to silence Corrupt Parliamentarians until Unfitness Cases got Corruption Findings and Dismissal Decisions against Top Judges.
- 3.8. The Citizen Father gave a Privilege Waiver and Confidentiality Waiver and use of his cases for Remedy Management by the Crown and Lord Bishops. Corruption Claim 2020 000968 and Fraud Appeal 2020 0742 got Remedy Denial Fraud Proof against the High Court and Court of Appeal. The B01B0837 Stay Application Hearing Audio Records on 23rd October 2020 add to it.
- 3.9. Appeal Lord Justices made a Damage Limitation Plan for themselves using a Fall Guy Conspiracy against Lower Rank Judges. They used Contempt Fraud Claim 2020 000286 and a Case Allocation Fraud that on 3rd November 2020 got an Audio Record that is Trial Fraud Proof against High Court Justice Mr Jay, and then on 9th November 2020 a Conflict Recusal from him.
- 3.10. It is time to use Claim B01B0837 and a 3rd Purchase Offer by the Youngest Son as Buying Agent for the Father as a Damage Limitation Test of Judges in the County Court, High Court and Court of Appeal.
