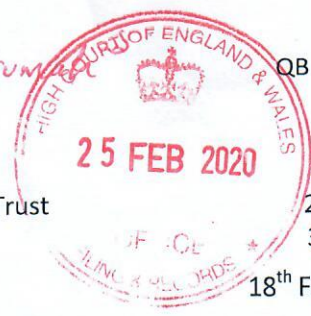

Claim Particulars

18<sup>th</sup> February 2020

1. They are Racially Prejudiced. White People committing Court Frauds against Black People.
2. The Ministry of Justice has made a Liability Admission and Settlement Offers. I want a lot more.
3. In 2003 a Residential Tenancy Agreement for 68 Selwyn Road, London E13 0PY was signed by Tenant *Mr Akwesi Nkrumah* and someone for East Thames Housing Group
4. London and Quadrant Housing Trust claim that the Landlord's Title was transferred to them. They have repeatedly failed to produce any evidence of the transfer.
5. Home Theft Conspirators planned a Dispossession Fraud. They used a Forged Tenancy Agreement with No Signatures for Possession Proceedings allegedly by London and Quadrant Housing Trust.
6. The Tenant resisted the Possession Proceedings.
7. The Theft Conspirators used a Motoring Prosecution Fraud and Court Room Eviction Fraud and Secret In Absence Trial Fraud to get a Conviction Fraud and Imprisonment Sentence Fraud and Arrest Fraud and Imprisonment Fraud.
8. The Tenant and his wife both filed Habeas Corpus Proceedings on 22<sup>nd</sup> July 2019 and got Issue Denial Fraud Proof against the Administrative Court
9. The Tenant served the Imprisonment Sentence Fraud. On his release he continued the Habeas Corpus Claim and got issue of it with reference CO 3798 2019 on 7<sup>th</sup> October 2019
10. The Ministry of Justice ignored the Fraud Liability and made Maladministration Liability Admissions and Settlement Offers.
11. The Queen used the Parliament Session Opening Speech to announce a Royal Commission to remedy Court Frauds. The Royal Commission needs Precedent Cases.
12. I understand the Royal Commission wants my cases for a Precedent Cases.
13. One will be for Habeas Corpus Claim Issue Denial Frauds.
14. Another is for the use of Criminal Prosecution Frauds for Property Dispossession Frauds.
15. The Precedent Cases get Criminal Conspiracy Proof firstly against Judges and then State Officers.
16. The Habeas Corpus Case Dismissal Order + Appeal Permission Refusal dated 15<sup>th</sup> February 2020 has resulted in a Fraud Appeal to the Supreme Court. They have not issued a Case Reference yet
17. The Sentence Enforcement Case 012000266764 in Thames Magistrates Court on 19<sup>th</sup> February 2020 will be used to get either a General Adjournment pending discovery of the outcome of the Royal Commission or Criminal Conspiracy Proof against the State and Law Courts
18. The Business Theft Criminal Complaint and Business Recovery Claim QB 2019 003741 and Corruption Claim QB 2019 003984 got Criminal Conspiracy Proof against the Metropolitan Police and High Court. It is Similar Fact Corruption Proof to that got by the Tenant. The Business Theft Plan used Immunity Frauds for 3 Women in exchange for Harassment Perjury. The Trial Judge noticed Innocence Evidence Concealment Frauds, supervised the Lay Jury into an Acquittal Decision and gave Claim Advice for the Victim against the Metropolitan Police, Ministry of Justice and Defenders. The Corruption Investigators observed what happened to him. The Victim lacked the capacity to manage a claim. The Harassment Framing Fraud failed. The Theft Conspirators used a Hygiene Regulation Breach Framing Fraud + Business Closure to get a Forced Sale and Business Theft. The Victim allowed use of the case for a Corruption Investigation. It got a Criminal Conspiracy Proof Set. It includes 2 Back Dated order Forgeries by the High Court. Test Cases used them and got Corruption Proof Classification Denial Fraud Proof and Irrelevant Evidence Declaration Proof against the State and Law Courts
19. Special and general and aggravated and exemplary damages of £1,000,000 or Money + House Recovery
