 - 6.3. The Top Judges used a High Court Master to issue the 1st Backdated Order Forgery with Alleged Date 31st October 2019 + 30 Day Case Stay + 30 Day Particulars Filing Time Limit + Filing Failure Automatic Strike Out + Day 23 Seal + Day 28 Letter Box Service
 - 6.4. The Top Judges called for a Criminal Investigation Fraud + Finding Fraud by the Metropolitan Police against the Citizen Victim. It got a Complainant Interview on Complaint Day 60 that was used to give to the Case Officers a Case Explanation + Evidence Schedule + Case Reference Advise to Superior Officers. The Fraud Proof Request Failures evidence an Investigation Refusal Decision.
 - 6.5. The Top Judges used a high Court Master for the 2nd Backdated Order Forgery with Alleged Date 12th November 2019 + Application Dismissal [without identification of the application] + Unintelligible Case Reason Fraud + Stayed Case Reason Fraud + Day 28 Seal + Day 40 Letter Box Service.
