Grounds: Fraudulent Breaches of Natural Justice + Human Rights + Overriding Justice Objective

The Crown and Lord Bishops imposed Corruption Remedy Conditions in the Parliament Session Agreement. They required a Royal Commission to deliver Corruption Remedies for Victims before the Session End with the Default Penalty of a Parliament Session Refusal and Forced General Election with Mass Publicity for the Corruption Proof, Remedy Denial Fraud Proof. On 19<sup>th</sup> December 2019 the Queen used the Parliament Session Opening Speech to announce it. The Crown and Lord Bishops need Integrity Tests that use State Frauds and Court Frauds committed since the 2019 General Election to get Corruption Remedies for Victims or Remedy Denial Fraud Proof against the Law Courts and Royal Commissioners to decide the Session Refusal and Forced General Election.

The Integrity Tests use Obvious Frauds and Known Frauds to discover whether the Law Courts use Contempt Powers to make Remedy Orders for Victims or Protection Frauds for Organised Criminals and Corrupt Officers.

Citizen Mr Nkrumah has Bias Fraud Proof against the Civil Courts and the Criminal Courts. He gave a Privilege Waiver and Confidentiality Waiver to enable the Crown and Lord Bishops to use the case for Remedy Publicity.

1. A Residential Tenancy Forgery that was used for a Possession Fraud by the County Court
2. A Prison Release Licence Forgery that was used for a Licence Breach Prosecution Fraud
3. Perjury Immunity Fraud by the Metropolitan Police and Crown Court
4. Appeal Process Denial Fraud
5. Habeas Corpus Issue Denial Fraud + Dismissal Fraud that is the subject of Supreme Court Fraud Appeal 2020 0055. It created Superior Jurisdiction Pending Adjudication Protection Rights and a Remedy Only Jurisdiction Limit for the Citizen against the Inferior Jurisdictions of the State and the Administrative Court.
6. The use of Conflict Jurisdiction for the Habeas Corpus and Case Stated Appeal Review CO 610 2020 Permission Refusal + Time Extension Refusal + No Merit Certificate was a Protection Breach Contempt Fraud
7. The absence of a Review CO 610 2020 Contest Notice or Dismissal Representations evidences that High Court Justice Mrs Eady acted as State Representative
