

Royal Commission + Possession Claim G00CR488 Defence and Counterclaim

Frauds. The Housing Association Officers did not have Ruin Fraud Powers. Ministry of Justice Officers procured Prosecution Frauds as Ruin Start Frauds from the Metropolitan Police that got Trial Frauds. They an Appeal Fraud to get and Appeal Dismissal Fraud by the Crown Court. He and his Wife filed Habeas Corpus Claims that got Issue Denial Fraud Proof against the Administrative Court. His Appeal discovered the Appeal Fraud. The Finish Ruin Frauds needed Witnesses + Investigators + Prosecutors + Court Officers + Trial Judges + Appeal Judges were Ministry of Justice Officers. They needed Computer Record Frauds for Anonymity + Case Misrepresentation Frauds. It got Criminal Conspiracy Proof against the Magistrates Court, Cuntly Court, Crown Court, High Court, both divisions of the Court of Appeal and the Supreme Court.

12.2. Top Judges sold Family Estate Theft Frauds BO1B0387 for the Son Trustee against the Father Beneficiary. It got Criminal Conspiracy Proof against the County Court, High Court and Court of Appeal

12.3. Top- Judges sold a Lease Possession Fraud F02Ed793 for the criminal Landlord against the Citizen Tenant

12.4. Shop Theft Claims QB 2019 003741 + 003984 are to remedy Shop Theft that used a Prosecution Fraud to get a Forced Sale, Representation Denial Frauds, Premature Possession and Purchase Price Payment Default. The 1st Prosecution Fraud failed. The Crown Court Judge noticed Innocent Evidence Concealment Frauds, supervised the Jury into an Acquittal Decision, and gave Claim Advice for the Victim against the Metropolitan Police, Ministry of Justice and Defence Representatives. Corruption Investigators. They got After Issue Criminal Conspiracy Proof against Top Police and Top Judges.

13. Contempt Claim Fraud 2020 000286 Trial on 3rd November 2020 got Status Conflict Qualification Fraud Proof + Recusal Fraud Proof against High Court Justice Mr Jay for ignoring Status as Witness + Initiator + Investigator + Prosecutor got 4 years 3 months earlier that he used to commit Court Frauds, and a Forced Recusal 3 days later. On 14th December 2020 the Trial Adjournment Judge has the choice of Fraud Enforcement or Fraud Remedies with the Parliament and the Crown waiting for the Audio Record



Defence + Counterclaim

1. The Landlord is not entitled to Forfeit or Re-possess the Property known as 179 High Street, Penge, London SE20 7PF
2. The Citizen Tenant denies the Alleged Breaches of assigning, underletting or parting with or sharing possession of the Property
3. The Breach Notice dated 7th February 2020 is invalid because there were no breaches
4. The Landlord is not entitled to re-entry and possession of the Property
5. The Landlord is not entitled to forfeiture of the lease.
6. The Landlord is not entitled the Breach Notice Costs because there was no breach
7. The Landlord is No Accounting + Interest Rights until the Claim and Counterclaim are tried
8. Top Judges formed Land Fraud Partnerships with Criminals, Lawyers and State Officers. The Fraud Methods include
 - 8.1. Prosecution Frauds as Business Sabotage Frauds that get Forced Sales and Representation Denial Frauds that get Payment Denial Frauds, and Physical Possession Frauds
 - 8.2. Court Possession Frauds
9. In early 2020 the Citizen Tenant relied on Competent + Integrity Misrepresentation Frauds when he appointed _____ as Business Managers and gave them entry to the Property. They committed Accounting Frauds from the time they got entry.
10. In early 2020 an Alcohol Licence Termination by the Local Authority substantially reduced the Turnover and Profit of a General Store. It compromised the ability of the Citizen Tenant to manage his business and deal with the Accounting Frauds of the Business Managers
11. The Citizen, Crown had Justice Responsibilities known as the Equity Monarchy Trusts. They have Corruption Control Jurisdictions that govern Parliament Session Powers. Since 2004 they have managed a Corruption Remedy Process. The Parliament Session Agreement between the Crown and Prime Minister. The Corruption Remedy Conditions required that a Royal Commission get Corruption Remedies before the Session End. On 19th December 2019 the announcement of it by the Queen in the Session Opening Speech was a Protocol Signal for Citizens to get Criminal Conspiracy Proof that silences Corrupt Politicians until Unfitness Cases get Corruption Findings and Dismissal Decisions against Top Judges. Corrupt Politicians used Commission Definition Arguments for Remedy Sabotage Frauds while Citizens got the Criminal Conspiracy Proof. Corrupt Officers used Evidence Destruction and Evidence Fabrication including Computer Record Frauds that are Forgery Proof and Perjury Proof against the Ministry of Justice and Law Courts. The Remedy Process needed Audio Records as Personal Responsibility Proof against Identifiable Individuals. Citizens got it.
12. Sample Land Fraud Cases against Illiterate Immigrants and Semi-Literate Immigrants
 - 12.1. Land Fraud Deals between Top Judges and Housing Association Officers needed Forged Tenancies. Citizen Mr Nkrumah made Forgery Complaints. Corrupt Officers demanded Protection
