

Royal Commission + Land Fraud Immunity Offer Response Reports

7th February 2021

TAKE NOTICE that:

1. The Drug Test Frauds used Incapacity Exploitation Frauds and State Schools to get Medical Access to Disabled Children and Crime Framing Frauds + Family Sabotage Frauds as Ruin Frauds against Corruption Victims as Protection Frauds for Guilty Individuals
2. The Housing Association Land Frauds used Tenancy Forgeries + Crime Framing Frauds + Family Sabotage Frauds to get Possession Frauds and Crime Framing Frauds + Family Sabotage Frauds as Ruin Frauds against Corruption Victims as Protection Frauds for Guilty Individuals
3. Unauthorised Medication Enquiries by Citizens Mr and Mrs Awodiya got Protection Fraud Demands by Teachers and Council Officers and a Ruin Fraud Response against Citizen Mr Awodiya that enabled him to get a Complete Set of Protection Fraud Proof against Guilty Parties including the Ministry of Justice Crime Partners
4. Forgery Complaints by Citizen Mr Nkrumah got Protection Fraud Demands by Housing Officers and a Ruin Fraud Response against Citizen Mr Awodiya that enabled him and Citizen Mrs Nkrumah to get a Complete Set of Protection Fraud Proof against Guilty Parties including the Ministry of Justice Crime, and then a Ruin Fraud Conspiracy against both Citizens Mr and Mrs Nkrumah.
5. On 1st February 2021 the Police Bail Fraud Appeal + Contempt Fraud Remedy Application got Application Resistance + Witness Exclusion Fraud until a Confidence Loss by the Crown Prosecutor and then a Confidence Collapse by Council Offers and Children return Decisions the next day.
6. On 9th February 2021 the Bail Return Date will be used by Citizens Mr and Mrs Nkrumah for Confidence Testing
7. The Remedy Process needed Lead Cases of Incapacity Exploitation Fraud Proof + Life Sabotage Fraud Proof for Children against Ministry of Justice Crime Managers that enabled Life Sabotage Joint Liability Findings + Greater Deterrent Penalties against the Procurers and Managers of Property Frauds
8. The Immunity Negotiation Offers in Lead Land Fraud Cases service the purpose of Life Sabotage Joint Liability Findings + Greater Deterrent Penalties

Land Fraud Lead Case F02ED793 got Criminal Conspiracy Proof against the Landlord, Representatives and Law Court Judges. Protection Fraud Demands by them. It got a Protection Fraud Condition that required New Frauds as Fraud Commitment Proof from the receivers before the Protection Fraud Supply. It got a Preliminary Fraud Condition by the Protection Fraud Receivers to give them New Fraud Confidence. They were given the 2020 000286 Restraint Breach Trial Frauds on 14th and 16th December 2020 against Equity Lawyer Mr Ellis by the High Court. It got a Secret Process that is evidenced by Possession Order Claim Frauds + Order Proof Denial Frauds + Possession Demand Frauds on 8th and 11th January 2021 by the Landlord and Representatives. They got Possession Order Proof Demands + Possession Refusals by the Citizen Tenant and an Immunity Negotiation Offer dated 11th January 2021 by the Equity Lawyer. Personal

Service at a Former Address of the Landlord by a Citizen Interpreter and Citizen Tenant that day got a Service Receipt Authority Denial the next day. Royal Commission Email Service on 18th January 2021 gets an Offer Response Failure Report dated 7th February 2021 by the Equity Lawyer

Land Fraud Lead Cases B01B0837 + F1PP7696 Mortgage Valuation Access Application got Process Denial Fraud Proof against the County Court and Protection Fraud Demands by the Trustee Son, Bank, Representatives and County Court Judges. It got a Preliminary Fraud Condition by the Protection Fraud Receivers to give them New Fraud Confidence. They were given the 2020 000286 Restraint Breach Trial Frauds on 14th and 16th December 2020 against Equity Lawyer Mr Ellis by the High Court. In January 2021 a Case Management Text Message from the Trustee Son proposed that he act a Mortgage Instalment Payment Agent for the Father. The Trust Frauds committed by the Trustee Son against the Father made it an Incredible Offer. The Royal Commission + Immunity Negotiation Offer Email from the Equity Lawyer to Family Members got an Oral Report by the Youngest Son that the Trustee Son continued to rely on the Trust Claim Fraud Lawyers for Case Management Advice. The Royal Commission Email Address List includes the Trust Claim Fraud Lawyers and gets Blocked Messages from them. A Contempt Fraud Investigation is needed to discover whether the Mortgage Repayment Agency Proposal was an Idiotic Idea by the Trustee Son or Case Management Advice by the Claim Lawyers. The result is an Immunity Negotiation Refusal Report dated 7th February 2021 by the Equity Lawyer.
