

Royal Commission + 2019 004208 Litigation Incapacity Intervention DRAFT Order 22nd February 2021

Before Lord Justice Mr Lewis and Justice Mr Spencer in Royal Court

Appearances by State Counsel Mr Eardley for the Solicitor General and IN Person by Citizen Ms Berry

1. Contempt Claim 2019 004208 Liability Defence + Contempt Penalty Self Representation

Incapacity Finding for Citizen Ms Berry against the Solicitor General for the Stated Reasons:

1.1. The Liability Trial on 10th February 2021 discovered Confused Behaviour Episodes and Rambling Rant Episodes that are Case Management Incapacity Proof for the Citizen against the State

1.2. Equity Lawyer Mr Edward William Ellis gave Case Management Advice that

1.2.1. the Citizen file in the Court of Appeal a Fraud Appeal that addresses the Key Issues, which are Conflict Qualification Fraud + Pending Appeal Trial Stay Protection Breach Contempt Fraud + Pending Appeal Remedy Only Jurisdiction Limit Breach Fraud + Litigation Incapacity Explanation Fraud with the Land Fraud Conflict Disqualification Proof

1.2.2. the Equity Lawyer draft Fraud Appeal Grounds + Proposals

1.2.3. the Citizen use the Penalty Hearing to ask the State Counsel, and if he refused, to ask the Trial Judges for Presentation Assistance by reading out the Fraud Appeal Grounds

1.3. the Citizen accepted the Case Management Advice

1.4. the Equity Lawyer produced the Fraud Appeal DRAFT Grounds + Proposals dated 15th February 2021 that used the phrases 'Confused Behaviour' and 'Rambling Rants' for Incapacity Validation

1.5. the Royal Commission Email sent at 20 53 on 15th February 2021 by the Equity Lawyer attached the DRAFT Grounds and made a Hampstead Case Preparation Help Request that discovered Restraint Frauds stopped Event Witnesses providing Case Explanation Help

1.6. the Citizen was offended by use of the phrases 'Confused Behaviour' and 'Rambling Rants' for Incapacity Validation

1.7. the Application Additions to the AMENDED DRAFT Grounds dated 19th February 2021 and Amendment Proposal Request by the Equity Lawyer got a Case Strategy Rejection + Appeal Grounds + Appeal Bundle + Appeal Filing by the Citizen

1.8. the Land Fraud Cases are Conflict Qualification Fraud Proof against All Judges of the High Court and Court of Appeal.

1.9. The Lease G02EC632 Title Transfer Specific Performance Application Hearing is listed for Wednesday 24th February 2021. The Defence Case + Application Response requires the Criminal Claimants to explain:

1.9.1. the Jurisdiction Fraud that used a New Claim in the County Court instead of the Shop Theft Claim 2019 003741 and Shop Theft Corruption Claim 2019 003984 in the High Court that vested Conflict Jurisdiction for the Shop Sale in the High Court

1.9.2. the Full Disclosure Denial Fraud that omitted any explanation of 3 Backdated Order Forgeries + the Possession Fraud Remedy Application made on 26th March 2020 by the Citizen Seller + the Trespass Restraint Application by the Criminal Buyers on 1st April 2020 that got Hearing Denial Fraud Proof for Both Parties against the High Court

2. Litigation Incapacity Intervention Obligation for the Citizen against the Attorney General for the Stated Reasons that the Justice Priority requires Competent Case Management and the Attorney General has Intervention Rights in All Cases to service the Justice Priority
3. Litigation Incapacity Intervention Conflict Disqualification Finding for the Citizen against the Attorney General for the Stated Reasons that the Attorney General used the Solicitor General for the Contempt Prosecution Fraud against the Citizen and the State Lawyers, State Counsel have Representation Responsibilities for the Attorney General and failed to use the Litigation Incapacity Evidence for Incapacity Remedies
4. Litigation Incapacity Intervention Jurisdiction Finding for the People against the Solicitor General and Attorney General for the Stated Reason that a Conflict Disqualifications gets a Jurisdiction Reversion to the Jurisdiction Source that in the circumstances is the People
5. Incapacitated Citizen Representation Jurisdiction Finding for Equity Lawyer Mr Ellis against the Solicitor General for the Stated Reason that his Case Management Expertise and Case History Knowledge are Best Qualification Proof for him against All Others
6. Incapacitated Citizen Representation Order for Citizen + Equity Lawyer Mr Ellis against the Solicitor General
7. Appeal Filing Time General Extension for the Citizen + Equity Lawyer against the Solicitor General for the Stated Reason that the Citizen has filed a Fraud Appeal
8. Contempt Fraud Investigation Order + Discovery Order + Contempt and Terrorism Penalty Warning + Default Penalty of a Case Dismissal and Contempt Liability Finding and Contempt Remedy Orders for the Citizen + Equity Lawyer against the Solicitor General that the Attorney General and Solicitor General do within 7 days file and serve Statements that explain when they discovered the Litigation Incapacity of the Citizen and what they did for Incapacity Remedy Management
9. Contempt Directions 1 Hour Hearing at 2 p.m. on March 2021 in Royal Court + Personal Attendance Order for the Citizen + Equity Lawyer against the Solicitor General
