1. The Citizen, Crown and Lord Bishops have Corruption Control Jurisdictions that govern Parliament Session Powers. Since 2004 they have managed a Corruption Remedy Process. It uses the Corruption Remedy proof Standard. It is Official Records that are Justice Proof for Honourable Officers or Guilty Proof and Credibility Irrelevance Proof for the Victim.
2. The Remedy Process has relied on Investigation Services provided by Equity Lawyer Mr Ellis. He has recruited Citizens and provided Case Management Services that got Proof Sets that meet the Corruption Remedy Proof Standard. The Equity Lawyer made the Strategic Decision to service the Remedy Process using Profit Fraud Corruption Cases of Adult Victims, then progress to Children Victims of Profit Frauds, and rely on Corrupt Officers to demand Protection Frauds and use the Worst Child Abuse Cases to get it. Events revealed it was a good decision
3. In December 2019 the Parliament Session Agreement contained Corruption Remedy Conditions. They required that a Royal Commission get Corruption Remedies before the Session End. The Default Penalty is a Parliament Session Refusal + Forced General Election with Mass Publicity for the Corruption Proof and Remedy Denial Fraud Proof.
4. Due Performance of the Remedy Conditions required Criminal Conspiracy Proof + Unfitness Findings + Dismissal Decisions against Top Judges by Parliament
5. The Remedy Process used Land Fraud Cases to get Profit Fraud Proof against Top Judges. It broke the confidence of Organised Criminals + Corrupt Representatives + Corrupt Officers who demanded Protection Frauds from Top Judges. The Protection Fraud Deals required Trial Frauds as Fraud Commitment Proof from the High Court to give Receiver the confidence to commit New Frauds as Fraud Commitment Proof to get Protection Frauds from the Court of Appeal. The Corrupt Officers used Paedophile Protection Frauds + Satanist Protection Frauds to provide the Fraud Commitment Proof. It contaminated the Land Fraud Managers with Joint Liability for Paedophile Protection Frauds. Some of them lost confidence.
6. The Royal Commission Emails from the Equity Lawyer served on the Cabinet and filed in the Law Courts and Parliament the Case Papers that are Criminal Conspiracy Proof against Top Judges.
