

Without Prejudice to Invalidity Arguments + Contempt and Terrorism Warnings

The Citizen, Crown and Lord Bishops have Corruption Control Jurisdictions that govern Parliament Session Powers. In 2004 European Leaders committed Election Frauds with intent to get Referenda Acceptance of the Dictator Powers in the European Constitution. The Lawful Business of British Citizens made inevitable the exposure of the Election Frauds. They used Extradition Frauds and Imprisonment Frauds in an effort to prevent exposure of the Election Frauds. The 1st Extradition Fraud Deal discovered that the Top Police, Top Customs and Top Judges were the Top Drug Dealers. The 2nd Extradition Fraud Deal required Innocence Evidence Concealment Frauds by the British Authorities before completion of the Imprisonment Frauds by the Dutch Authorities. It needed a Protection Fraud Deal that traded Full Co-operation from the Top Drug Dealers in exchange for Protection Frauds for them. It got Corruption Proof. Equity Lawyer Mr Ellis used it for a Corruption Notice to the Crown and Parliament. It revived use of the Parliament Session Jurisdictions after a Dormancy Period of 45 years. It started a Corruption Remedy Process that has continued ever since.

In December 2019 the Parliament Session Agreement between the Crown and Prime Minister required Corruption Remedies before the Session End. The Default Penalty is a Parliament Session Refusal and Forced General Election with Mass Publicity for the Corruption Proof and Remedy Denial Fraud Proof. Corruption Remedies needs either Case Remedies by the State and Law Courts or Remedy Denial Fraud Proof against them.

Court Frauds get Protection Fraud Fees and Crime Profits for the Top Judges. The Court Fraud Market relies on Fraud Commitment Proof from the Law Courts to give Organised Criminals and State Officers the confidence to pay Protection Fraud Fees and share Crime Profits.

Contempt Jurisdiction empowers Perversion Remedies. It is the Top Jurisdiction of Law Courts. The Top Contempt Jurisdiction of the Law Courts is Contempt Appeal Jurisdiction to the Supreme Court. The Administration of Justice Act 1960 vested it in the House of Lords the Appeal Jurisdiction against Contempt Decisions of the High Court. Jurisdiction Legislation created the Supreme Court and transferred to it the Law Court Functions of the House of Lords except the Parliament Session Jurisdictions of the Supreme Court.

Top Judges used Contempt Trial Frauds by the High Court, Appeal frauds by the Court of Appeal and Contempt Immunity Frauds by the Supreme Court to provide Fraud Commitment Proof for the Court Fraud Market.

Citizens are using Court Frauds for Contempt Fraud Appeals to the Supreme Court to get either Corruption Remedies or Protection Fraud Proof and Crime Proof for Corruption Findings and Dismissal Decisions against Top Judges by Parliament. The Family Estate Trust Frauds by the Trustee Son, Bank of Scotland and Lawyers against the Citizen Beneficiary Father are excellent for the purpose
