The document entitled Royal Commission + F00WT279 + F21YY087 + E01WT861 Notice + Observations + Log for the period from 6<sup>th</sup> February 2019 to 23<sup>rd</sup> April 2021 reveals the Help Requests by Citizen Mrs Tedla to Equity Lawyer Mr Ellis and Other Communications. They are Litigation Incapacity Proof + Incapacity Exploitation Fraud Proof for Citizen Mrs Tedla against All Liable Parties. Witness Protection requires Reasonable Efforts at Damage Mitigation by the Protection Applicant and Protected Party.
