Thank you for your email. Re: TV Edwards - I had and still have a big problem with them. I have made complaints against them but also need to make complaints to the Law Society but do not know how to do it. The reason why I am in this situation i.e. have this new claim is because they fail to litigate sufficiently in the previous Court Hearing I had in May 2019. I strongly believe that the Judge granted Forfeiture wrongly as the Claimant did not follow even the standard protocol and let alone how they went about it. I want to appeal against the decision if possible, if not to set aside against the decision.

I also informed Ryan Williams that Jon Finebaum, the Claimant's lawyer did something inappropriate and unprofessional in the course of the Hearing but Ryan ignored my instruction and did not want to take any action against the claimant's lawyer. TV Edwards refused and declined to advise me immediately after the Hearing and yet without notifying me or without my consent TV Edwards also tried to amend my Legal Aid Application in order to get more money from the Legal Aid. The value of my property currently is approximately between 750,000 - 800,000. (But I have not valued it recently.) The two law firms i.e

COMPTONS, the lawyers of the resident's association and WALKER MORRIS, the lawyers of the mortgage company and my previous lawyer, Roger Hardwick, from BRETHERTONS are collaborating together in order to evict me because I have EQUITY and they know I am also VULNERABLE as I am a litigant in person. They are all doing this by adding exorbitant amount of charges in order to eat away the equity.

Birmingham Midshires (BM) is mortgage company and I bought the property in 24th May 1988 for approximately 150,000 and borrowed only 50,000. Now BM is stating in their most recent letter that my balance is 158,000. I have no idea how this amount came about. I tried to write them a letter requesting for a breakdown but without and also tried to call them but they refused to talk to me. I also have an issue with them. Moreover, I discovered that BM made agreement with another company (GENTRA) as the assigned mortgagor.

I continue to challenge and dispute the outstanding balance by engaging an accountant, who is a friend, who did a proper breakdown up to 2018. I will request for an update once I get the BM statement. But my strategy now is whilst challenging the outstanding amount, I am looking to move to other lender - either by re-mortgage or other options. This way I will prevent COMPTONS to have less or no access to my mortgage account; and also it is easier to focus on one major enemy instead of 2 enemies.

I am keen to learn more about TV Edwards and can send you their costs for you to read. Because I will need to know as I need to report them to the Law Society. Needless to add, he did not even draft my Skeleton of Argument and also got help to draft with the Witness Statement.

I hope I have answered all your questions and sorry I am so emotional about all these so I got carried away.

Please find attached the original i.e. not varied LEASE OF 1988. It is not the best quality copy. Please let me know if you are having difficulties so I can scan it again.

I am also attaching the last Court Order of 28 May 2019 - from the previous CCRAL Claim of 2018/2019. As you can see, the legal costs is a staggering amount; the amount for the claimed service charge was about 6555.00 pounds and even then, nobody was clear whether this was non-payment of service charge or something else as for the decision of the First Tier in 2012 or 2014. The management co. cannot still clarify which year it is supposed to cover for service charge.

Moreover, I do not believe that Birmingham Midshires (BM), the Mortgage Company is entitled to add/make LEGAL PAYMENT or legal costs on to my mortgage account. It is however entitled to make payment for the non-payment of service charges because it has also interest on the property and to avoid/prevent Forfeiture.

BM has been adding exorbitant amount of legal charges by previous lawyers of the Management Company claiming it is for Service charges and when it is not. This is the real bone of contention and this is how the whole dispute started. I can cross-evidence all payments I have made from the beginning because I have all their demands and receipts. But the management company cannot provide any of accounts because they were so corrupt and never kept a proper and transparent account.

So, I would like to know whether a mortgage co. is entitled to put/add legal cost charges to my mortgage account and if it is legal?
