The Grievance

Dictator Politicians made a Governance Fraud Plan. It needed replaced of the Justice Priority of the People with Common Law Methods using Unbiased Justice Officers by the Obedience Priority of the State with Bias Frauds using Biased Justice Officers. The Politicians lost control to State Officers and Law Court Judges who formed Crime Partnerships. They developed Protection a Fraud Network to provide Support Services and Corruption Co-ordination. They replaced the Obedience Priority of the State with the Predation Priority of Organised Crime. The Protection Fraud Network managed the Protection Fraud Market. The Worst Risk was Immunity Deals that got Protection Fraud Conspiracy Proof against Top Judges. The Risk Control Protocol required Fraud Commitment Proof from Receivers before the Protection Fraud Supply. Routine Business used Case Frauds as Fraud Commitment Proof. Special Business required New Frauds as Fraud Commitment Proof from the Receiver. Very Special Business required Preliminary Frauds by the Law Courts to give Receivers the confidence to commit New Frauds before the Protection Fraud Supply. The Dictator Politicians dare not hold Governance Referenda because they would be an Education Process. It would case Voters to understand the Governance Choice was between Absolute Predation Power for the Protection Fraud Network or Corruption Control Powers for the Citizen using the Parliament Session Jurisdictions. The Dictator Politicians used Sabotage Frauds against the Parliament Session Jurisdictions in the hope that a Dormancy Period would cause everyone to forget how they worked and then what they were. It failed. In 2004 Referenda Election Fraud Conspiracy Proof against European Leaders was used for a Corruption Notice that ended the Dormancy Period, revived uses of the Parliament Session Jurisdictions and started a Corruption Remedy Process that has continued ever since.

In 2014 Remedy Successes forced the Protection Fraud Network to use a Business Expansion to avoid Total Collapse. They chose Family Sabotage Frauds + Child Thefts to get Big Budgets + Budget Fraud Profits + Child Trafficking + Fraud Profit Money Laundering Services from Sovereign States. It needed a Target Community and Business Priming Case that got Fraud Knowledge Admissions + Remedy Denial Fraud Commitments from hundreds of State Officers and Law Court Judges. They chose the Community Divisions made the Cypriot Community an Obvious Target. They chose Family Sabotage Frauds against the Mother + 6 Children it got a Big Budget and had a Fraud Conspiracy got Fraud Co-operation for the State from the Father in exchange for Divorced Property Frauds for the Father against the Mother.
