Katsiaounis might be a Rare Name because a Family Majority of Religious Defectors abandoned it or Family Minority adopted it to continue with Greek Orthodoxy or Religious Division might be Totally Irrelevant. Civil War and the Turkish Invasion added to the Community Divisions. The Cultural Legacy of Taxation Bias for the Wealthy against the Poor and Community Divisions resulted in a Lost Common Heritage. I witnessed Cypriot Migrants in the 20<sup>th</sup> Century bring the Cultural Legacy and Division Baggage with them to the UK. I witnessed some achieve Great Wealth using Tax Avoidance Services + Money Laundering Services by the Cypriot State. It made the Cypriot Community an Obvious Target for two things:

1. The Business Priming Operation for Family Sabotage Frauds + Child Thefts + Big Care Budgets + Budget Fraud Profits + Money Laundering Services from Sovereign States
2. The Business Priming Operation for Ruin Frauds against Wealthy Cypriots using Tax Avoidance Frauds
