Justice Offices. The Citizen provides Investigation Services at every Governance Level.

Jurisdiction Separation creates a need for Specialist Jurisdictions for Prosecution and Adjudication.

The Justice Process Contempt Remedy Powers Set are the Justice Priority Enforcement Powers.

General Elections return Governing Majorities. Parliament Session Jurisdictions decide the Corruption Control Priorities of Parliament Sessions. The Glorious Revolution vested the Parliament Session Jurisdictions in the Citizen, Crown and Lord Bishops. Citizen has the Investigation Jurisdiction. The Crown has Prosecution Jurisdiction. It is the power to issue Trial Orders for Corruption Cases against the State and Unfitness Cases against Officers and Authorities. One Lord Bishops has Court Lawyer Jurisdiction for the Trial Court, and the other for the Appeal Court. The 24 Lord Bishops provide up to 12 as Trial Jurors and up to 12 Others as Appeal Jurors. The Law Professions evolved to service the Citizen.

A Governance Fraud Conspiracy by Dictator Politicians used a Dictator Governance Plan. It substituted the Obedience Priority of the State for the Justice Priority of the People. It substituted Conflict Disqualification from Justice Offices for Conflict Qualification Frauds for Justice Offices. It used the Contempt Remedy Power for Unjust Obedience Enforcement for the State.

The Dictator Politicians lost control to State Officers and Law Court Judges. They formed Crime Partnerships to exploit Dictator Powers. They substituted the Predation Priority of Organised Crime for the Obedience Priority of the State.

The Corruption Remedy Process of the Parliament Session Jurisdictions is recovering Equity Governance. The Equity Lawyer provided Case Management Services. They got Conflict Qualification Fraud Proof + Adjudication Denial Fraud Proof + Protection Fraud Proof + Crime Profit Proof for the Parliament Session Jurisdictions against Criminals, State Officers and Law Court Judges. The Inherent Remedy Jurisdiction Denial Notice Fraud is Joint Liability Proof against All Judges of the Supreme Court.
