### Negotiation Limits

1. The Contempt Fraud Appeal of Equity Lawyer Mr Ellis against the Solicitor General includes Witness Protection Applications for the Citizen and Other Corruption Victims. It needs Mitigation Efforts that get either Voluntary Remedies that eliminate the need for Protection Orders or Remedy Denial Fraud Proof that supports the Witness Protection Case.
2. A Settlement Deal needs Evidence Preservation Obligations for Both Parties because it is Corruption Proof against the State and Law Courts. It is Relevant Evidence for Parliament Session Jurisdictions.
3. The Trust Frauds by the Trustee Son included Claim Contempt Frauds + Order Breach Contempt Frauds by the Trustee Son, Trust Claim Lawyers and Bank of Scotland. They caused Chronic Stress Damage and created an entitlement for Special + General + Aggravated + Exemplary Damages that far exceed the Personal Resources of the Trustee Son.
4. The Trust Breach Risk for Clients invalidates Financial Service Unfitness Immunity for the Trustee Son. Remedy Co-operation by the Trustee Son that gets Full Disclosure + All Supporting Evidence about the Entire Process that resulted in the Trust Frauds + Profession Unfitness Frauds + Order Breach Contempt Immunity Frauds + Remedy Denial Frauds will validate Criminal Immunity for the Trustee Son and a Liability Transfer Order against the Other Liable Parties
5. The Contempt Fraud Remedy Claim 2020 000968 + Reopening Consent Order + Liability Release Order for the Trustee Sons will result in Liability Increases against the Prime Minister, Trustee Sons, Lawyers Harris Waters, Bank of Scotland, Ministry of Justice and Law Society. Party Status Orders can be used against Additional Liable Parties
6. Every Decision needs Details Reasons.

The Protection Fraud Network
8. The Politicians made a Dictator Governance Plan. It used the European Constitution to vest Dictator Powers in the State. In every Member State of the European Union the Politicians lost control to State Officers and Law Court Judges who formed Crime Partnerships and developed Protection Fraud Networks to provide Support Services and Corruption Coordination.
9. The Protection Fraud Networks managed the Protection Fraud Market. The Worst Risk was Immunity Deals that got Criminal Conspiracy Proof against Top Judges. The Risk Control Protocol required the Receiver to provide Fraud Commitment before the Protection Fraud Supply. Routine Business used the Case Frauds and Fraud Commitment Proof. Special Business required New frauds as Fraud Commitment Proof. Very Special Business required Preliminary

Frauds by the Supplier to give the Receivers confidence to commit New Frauds before the Final Protection Fraud Supply.

10. Protection Fraud Fees did not satisfy Top Judges. They wanted Crime Profits. They needed a Crime Management Business to get the Crime Profits. A Crime Partnership of Top Judges and Top State Officers in the Ministry of Justice provided Corruption Co-ordination Services that enabled Organised Criminals to get the use of Investigation Powers and Prosecution Powers for Ruin Frauds against Victims.

#### The Parliament Session Jurisdictions and the Remedy Process

11. General Elections get a Governing Majority. Parliament Session Jurisdictions decide the Corruption Remedy Priority of Parliament Sessions. The Citizen has Investigation Jurisdiction. The Crown has Prosecution Jurisdiction. It is the power to issue Trial Orders of Corruption Cases against the State and Unfitness Cases against Officers and Authorities. The Lord Archbishops have Court Lawyer Jurisdiction, one for the Trial Court and the other for the Appeal Court. The Lord Bishops have Adjudication Jurisdiction. There are 24 of them so that up to 12 can sit as Trial Jurors and up to 12 Others can sit as Appeal Jurors. They use the Corruption Remedy proof Standard. It is Official Records that are Justice Proof for Honourable Officers or Guilt Proof against Corrupt Officers ad Credibility Irrelevance Proof for the Victim. It eliminates the need for Witness Attendances or Witness Credibility Findings and gives everyone confidence that Trial Order made by the Crown will get Rapid Processing.
12. The Dictator Plan of the Politicians got a Dormancy Period of the Parliament Sessions. In 2004 European Leaders used an Election Fraud Conspiracy with intent to get Referenda Acceptance of the European Constitution and Dictator Powers. Equity Lawyer Mr Ellis got Election Fraud Proof and used it for a Corruption Notice to the Crown and Parliament. It revived the Parliament Session Jurisdictions. It started a Corruption Remedy Process that has continued ever since.

#### The Child Trafficking Business

13. A Joint Venture of the Ministry of Justice Crime Partners and Child Care Authority Crime Partners used Family Sabotage Frauds + Child Thefts to get Big Care Budes + Budget Fraud Profits + Money Laundering Services, and in some cases, Expatriation Frauds to get Money Laundering Services by Sovereign States.

#### 14. A Joint Venture of Ministry of Justice Crime Partners and Police Crime Partners used

Prosecution Frauds + Liability Frauds + Forced Sale Frauds + Possession Frauds + Enrichment Frauds for Crime Partners + Impoverishment Frauds against Victims.

#### The Trust Frauds

15. In 1953 the Citizen Father was born into a poor Indian family. He had very limited education. In 1976 he spoke no English when he came to England for an Arranged Marriage. He is a Successful Immigrant. He learnt basic English, had a successful working life and a successful marriage with four children.
16. A Wisdom Tooth Operation Failure resulted in the Over Sedation Death of the late Mrs Sood. It left the Citizen a Widower with 4 Children. He used the £150,000 Medical Negligence Damages to establish a Family Trust that bought a House and 2 Flats with Buy to Let Mortgages and his Son as Trustee. The Citizen Father was the Tenant of the House which was the home for him and the Children. He let the Flats and used the Rent Payment for Mortgage Payments.
17. The Trust Accounting Skills Deficit of the Citizen creates a need for Full Accounting for the Trust Period to discover the Beneficial Entitlement of the Citizen.
18. In 2013 the Son Trustee got engaged to be married. The Son Trustee signed a Trust Declaration that acknowledged the Citizen Father as the Trust Beneficiary.
19. In 2014 the Son Trustee got possession of one of the Flats and occupied it and did not pay any rent to the Citizen Father. The discovery of Known Frauds creates a need for Full Accounting for the Trust Period to establish whether or not there are Unknown Frauds.
20. In 2015 the Son Trustee got issue of Claim B01B0837 and used it to get a Possession Order and Sale Order against the Citizen Father.
21. The Citizen Father had Another Son, the 4<sup>th</sup> Child. He got a Mortgage Offer and acted as Agent Buyer for the Citizen Father with intent to become Replacement Trustee. Twice it got Sale Refusal Fraud Proof that was Order Breach Contempt Fraud Proof + Contempt Fraud Remedy Denial Fraud Proof + Mortgage Redemption Statement Denial Fraud Proof + Mortgage Redemption Denial Fraud Proof against the Son Trustee, Lawyers, Bank of Scotland and County Court Judges. The discovery of Known Contempt Frauds creates a need for a Contempt Fraud Investigation to discover All Damage and identify All Liable Parties

#### The Corruption Remedy Process

22. The Corruption Remedy Process got Successive Sets of Corruption Proof and Remedy Denial Fraud Proof. In 2017 it was used to get a Forced General Election, in June 2019 to get a Forced

Resignation from Prime Minister Mrs May, in October 2019 to get a Forced General Election before the Year End, and in December 2019 to get a Parliament Session Agreement that required Corruption Remedies before the Session End. Citizens used their cases for Integrity Tests to get either Case Remedies by the Law Courts or Remedy Denial Fraud Proof + Profit Fraud Proof + Crime Profit Proof against them

23. A Friend introduced the Citizen to Equity Lawyer Mr Ellis. The Citizen gave a Confidentiality Waiver and Privilege Waiver. It enabled Case Management that got Proof Sets that met the Corruption Remedy Proof Standard and were Admissible Evidence for the Parliament Session Jurisdictions.
24. The Contempt Immunity Frauds were Protection Fraud proof and Crime Profit Proof for the Parliament Session Jurisdictions against the Law Courts
25. The Remedy Denial Fraud Claim 2020 000968 got Additional Remedy Denial Fraud Proof for the Citizen and Parliament Session Jurisdictions against Trustee Son and the High Court. The Contempt Fraud Appeal 2020 0742 got more of it for them against the Court of Appeal.
26. The 3<sup>rd</sup> Mortgage Offer for the 3<sup>rd</sup> Son was used for a Mortgage Valuation Access Application by the Citizen. It got a Hearing Denial Fraud Proof against the County Court and Mortgage Repayment Denial Fraud Proof against the Bank of Scotland. The Settlement Negotiation Offer in January 2021 to the Trustee Son got the Rapid Response of an Eviction Enforcement Application Fraud by the Trustee Son against the Citizen. A Service Notice from the Court to the Citizen enclosed a Stamped Copy of the 1<sup>st</sup> Page was a Hearing Denial Notice. On the evidence available a Remedy Application by the Citizen got an Eviction Application Hearing Notice and Mortgage Valuation Access + Remedy Application Hearing Denial Frauds.
27. Other Cases broke the confidence of Top Judges. It got a Remedy Application Hearing and then use of the Eviction Hearing for All 3 Applications. The Contempt Fraud Appeal of the Equity Lawyer against the Solicitor General Includes Witness Protection Applications for the Citizen Father and Others. They need Damage Mitigation Effort Proof. The Settlement Negotiation Offer will get either Voluntary Remedies from the Trustee Son or Remedy Denial Fraud Proof against him.
