TAKE NOTICE that the Contempt 2020 000286 Trial Fraud Proof is being used for the Contempt Fraud Appeal to the Court of Appeal. It includes Witness Protection Application for Corruption Victims. A Land Fraud Deal by the Ministry of Justice Crime Partners and Housing Association Offers. It needed Forged Tenancies. Forgery Complaints by Citizen Mr Nkrumah motivated a Ruin Fraud Conspiracy against him. He gave a Privilege Waiver and Confidentiality Waiver and use of the Ruin Fraud Case to the Parliament Session Jurisdictions. It got Criminal Conspiracy Proof against the Ministry of Justice Crime Partners. It included Computer Record Fraud Proof against the Ministry of Justice Crime Partners.

TAKE NOTICE that on the available evidence the Drug Supply Trial 2020 7219 and the Prison Release Habeas Corpus Claim CO 2021 7219 of Mr Gordon are Fit Cases for the Corruption Remedy process of the Parliament Session Jurisdictions because they have Similar Profiles to the Ruin Fraud Cases against Citizen Mr Nkrumah. The Best Advice for the Drug Supply Trial 2020 7219 Defenders is to use Royal Commission Corruption Proof + 2020 7219 Prosecution Delays as Conflict Jurisdiction Deficit Evidence for a Case Dismissal Application.

Stated Reasons

The People chose Just Governance. It uses a Common Empowerment and a Common Obligation for everyone to use the Common Law Processes of Truth Discovery and Just Reasoning to service the Justice Priority with priority for Sustainable Peace. It needs Corruption Controls at every Governance Level. General Elections are a Corruption Control. They prevent Long Term Empowerment in Small Cliques by getting a New Governing Majority. The Citizen, Crown and Lord Bishops have Corruption Control Jurisdictions that govern Parliament Session Powers. They decide Corruption Remedy Priorities for Parliament Sessions.

The Parliament Session Agreement dated December 2019 required Corruption Remedies before the Session End. It needed Remedy Proof for the Law Courts or Remedy Denial Fraud Proof against them. Citizens used their cases for Integrity Tests that got Remedy Denial Fraud Proof against them.

Top Judges and Top State Officers formed Crime Partnerships. They developed the Protection Fraud Network. It manages the Protection Fraud Market. The Worst Risk is Immunity Deals that get Protection Fraud Conspiracy proof against Top Judges. The Risk Control Protocol requires Fraud Commitment Proof from Receivers before the Protection Fraud Supply. Routine Business uses the Case Frauds as Fraud Commitment Proof. Special Business requires New Frauds by the Receivers as Fraud Commitment Proof. Very Special Business requires Preliminary Frauds by Law Courts to give Receivers the confidence to commit New Frauds before the Protection Fraud Supply.

Top Judges were not satisfied with Protection Fraud Fees. They wanted Crime Profits. The Ministry of Justice Crime Partners provided Crime Management Services to get the Crime Profits. They made Joint Venture Deals with Business Customers who did not have Investigation Powers and Prosecution Powers needed for Ruin Frauds against Corruption Victims. The Ministry of Justice Crime Partners procure Business Services from State Authorities that have Ruin Fraud Powers.

Fraud Proof on anything gets a Fraud Presumption on Everything Else for the Fraud Victim against the Fraud Managers and Fraud Beneficiaries. It is subject to Rebuttal Proof. Mr Gordon has the benefit of the Fraud Proof got by the Corruption Remedy Process against the Ministry of Justice Crime Partners. His History and Case Circumstances raise Reasonable Suspicions that the Drug Crime Prosecution against him is an Intimidation Fraud for Business Customers of the Ministry of Justice Crime Partners.
